### ORDER:

During the Budget session of Tamil Nadu Legislative Assembly on 2019-2020, among others, the Hon'ble Minister (Health and Family Welfare) has made the following announcement:

"Construction of Additional building to Government Hospitals at Bhavan, Rasipuram, Kumarapalayam, Pabanasam, Kolaroattai, Thondamuthur, Bodinayakanur, Arani and Government Headquarters hospital Mammakkudi at a total cost of Rs.13.5 crore"

2. Based on the above announcement, the Director of Medical and Rural Health Services among others has sent proposal along with the Rough Cost Estimate prepared by the Engineer-in-Chief(Building) and Chief Engineer (Buildings) Chennai Region, Public Works Department for the work of construction of additional building to Government Hospital, Bhavani, Erode District, at the cost of Rs 1.50 crore for the year 2020-2021

3. The Director of Medical and Rural Health Services has requested the Government to accord administrative and financial sanction for a sum of Rs.1.50 crore for the year 2020-2021 for Construction of a additional building to Government Hospital, Bhavani, Erode District.

4. The Government after careful examination of the proposal of the Director of Medical and Rural Health Services in detail and decided to accept the same. Accordingly, the Government do and hereby accord administrative and financial sanction for a sum of Rs.1.50 Crore (Rupees One crore fifty lakhs only) for Construction of a additional building for Government Hospital Bhavani, Erode District provided no further revised Administrative sanction is sanctioned.

5. The amount sanctioned in para 4 above shall be debited to the following Head of account:-

6. The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer, Public Works Department is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency fund to Finance(BG-I) Department directly in Form A appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the contingency Fund will be issued from Finance (BG-I) Department. The Chief Engineer, Public Works Department is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2020-2021 to Finance (BG-I)/Health-II Department at the appropriate time without fail.

7. This order issues with the concurrence of the Finance Department vide its L.O.No.47339/Health-II/2020, dated 24.12.2020 and ASL No.1254 (One Thousand two hundred and thirty four).
