### ORDER:

The Mission Director, National Health Mission in the letter read above has stated that the Government of India have released and credited into State Government Account its share towards Release of Grants-in-Aid for Other Health System covered under National Urban Health Mission Programme during 2018-19 as detailed below:-

The corresponding 40% of the State share against the 60% of the Government of India share of Rs.11,52,00,000/- (Rupees Eleven crore and fifty two lakh only) works out of Rs.7,68,00,000/- (Rupees Seven crore and sixty eight lakh only).

2. The Mission Director, State Health Society has therefore requested the Government to issue orders for the release of a sum of Rs.19,20,00,000/- (Rupees Nineteen crore and twenty lakh only) being the State and Central Share contribution of Grants-in-Aid for Other Health System covered under National Urban Health Mission during the year 2018-19 as mentioned above and to authorize him to draw

the above amount under National Health Mission through Treasury mode and credit it into National Health Mission Account.

3. The Mission Director, National Health Mission has also requested the Government to re-appropriate a sum of Rs.19,20,00,000/- (Rupees Nineteen crore and twenty lakh only) from the Head of Account "2211 00 103 UA 09 32" (General) to Head of Account "2211 00 103 UC 09 38" (General).

4. The Government after careful consideration has decided to accept the above proposal of the Mission Director, National Health Mission and accordingly:

- i. A sum of Rs.19,20,00,000/- (Rupees Nineteen crore and twenty lakh only) being the State and Central Share contribution of Grants-in-Aid for Other Health System covered under National Urban Health Mission during the year 2018-19 is sanctioned to the Mission Director, National Health Mission.
- ii. A sum of Rs.19,20,00,000/- (Rupees Nineteen crore and twenty lakh only) is reappropriated from "2211 00 103 UA 09 03 (General) to 2211 00 103 UC 09 03" (General)

5. The amount sanctioned in para 4 above shall be debited to following heads of account:-

6. Necessary funds will be provided in the RE/FMA 2018-19. Pending provision of such funds in RE/FMA 2018 – 19, the Mission Director, State Health Society/Project Director, Reproductive and Child Health Project, Tamil Nadu is authorized to draw and disburse the amount sanctioned in para 4(i) above. However, this expenditure shall be brought to the notice of the legislature by specific inclusion in the Supplementary Estimates 2018 – 19. The Mission Director, State Health Society/Project Director, Reproductive and Child Health Project, Tamil Nadu is also requested to include this expenditure while sending the budget proposals for RE/FMA 2018-19 and draft Supplementary Estimates 2018-19 to Government in Finance (Health-I) Department without fail.

7. The Mission Director, State Health Society / Project Director, Reproductive and Child Health Project, Tamil Nadu is authorized to draw the amount sanctioned in para 4 above and to credit it into State Health Society Account.
