National Health Mission – Establishment of Pain and Palliative care Units in 12 Districts namely Ariyalur, Dharmapuri, Karur, Madurai, Nagapattinam, Nilgiris, Perambalur, Pudukkottai, Sivagangai, Theni, Virudhunagar and Chennai – Sanctioned - Orders – Issued.

#### ORDER:

"The Hon'ble Minister for Health, Government of Tamil Nadu has Announced in the State Legislative Assembly that Pain and Palliative Care Units will be set up in 12 District in Phase-III".

- 2. In the Government Order first read above, the Government issued orders for establishment of Pain and Palliative Care Units in 10 Districts (Phase I) (Cuddalore, Dindigul, Thiruvarur, Tiruvannamalai, Tiruvallur, Krishnagiri, Ramanathapuram, Thoothukudi, Tiruppur and Namakkal).
- 3. In the Government Order second read above, the Government issued orders for establishment of 10 more districts (phase.II) namely (Kanchipuram, Coimbatore, Viliupuram, Vellore, Thanjavur, Erode, Trichy, Salem, Tirunelveli and Kanniyakumari District Headquarter Hospitals)
- 4. In the Letter third read above, the Mission Director, State Health Society has stated that in continuation of the above, Government of India have approved for the establishment of Palliative Care units in the remaining 12 (Phase III) districts namely Ariyalur, Dharmapuri, Karur, Madurai, Nagapattinam, Nilgiris, Perambalur, Pudukkottai, Sivagangai, Theni, Virudhunagar and Chennai, in Record of Proceedings 2018-2019. In this regard Executive Committee approval has been obtained for establishing palliative care units as detailed below:
  - At District Head Quarters Hospital in nine districts namely Ariyalur,
  - Dharmapuri, Nagapattinam, Nilgiris, Perambalur, Sivagangai, Theni, Virudhunagar, Madurai.
  - In Medical College Hospitals in two districts namely Karur & Pudukkottai.

- At Royapettah Government General Hospital for Chennai District.
- **5.** He has also reported that in the Record of Proceedings 2018 19, it has been approved to implement services under National Programme for Palliative Care in the 12 Phase III districts as presented below:-

- viii. The Mission Director National Health Mission is requested to ensure that the contractual agreement between the Outsourcing Agency and State Health Society denies the opportunities of the employees to claim any right for absorption. The Outsourcing Agency is also being held responsible for future litigation.

The Director of Medical and Rural Health Services and Director of Medical Education is also requested to send a draft explanatory notes for including the above expenditure in the Supplementary Estimate 2018 – 2019 to Finance (BG-I / Health-1) Department without fail.
