ORDER:

The post of Radiographer is classified under Category 2, Class II, Branch IV of the Special Rule for the Tamil Nadu Medical Subordinate Service. In the Government order first read above, among others, orders have been issued for delegating the appointing authority powers to Director of Medical Education and Director of Medical and Rural Health Services only for the post of Radiographers as there were no sanctioned posts of Radiographers in the Directorate of Public Health and Preventive Medicine.

- 2. In the Government order second read above, 106 Radiographer posts have been sanctioned for the 106 upgraded Primary Health Centres. In the Government letter third read above, the Government have accorded permission to the Director of Public Health and Preventive Medicine to fill up the 106 vacancies in the category of Radiographer through Employment Exchange, duly following the rules of reservation, pending issue of amendment to the rules for the post. Accordingly, 106 posts of Radiographers were filled up, by the Director of Public Health and Preventive Medicine and subsequent Radiographers posts are being filled up, as and when the Government have accorded sanction to the above post, while strengthening the Upgraded Primary Health Centres.
- 3. In the letter fourth read above, the Director of Public Health and Preventive Medicine has requested the Government, to issue necessary amendment to rules governing the post of Radiographer in the Tamil Nadu Medical Subordinate Service, so as to include the Director of Public Health and Preventive Medicine as one among the appointing authority for the post of Radiographer sanctioned to the Directorate of Public Health and Preventive Medicine.

- 4. The Government have examined the request of the Director of Public Health and Preventive Medicine carefully and have decided to include the Director of Public Health and Preventive Medicine also as the appointing authority for the post of Radiographer in Primary Health Centres.
- 5. The appended notification will be published in the <u>Tamil Nadu Government Gazette.</u>

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Medical Subordinate Service (Section 21 in Volume III of the Tamil Nadu Services Manual, 2016)

2. The amendment hereby made shall be deemed to have come into force with effect from 24th March 2008.

AMENDMENT

In the said Special Rules, in Part-II, under the heading "Branch IV General", in Annexure I (referred to in rule 4), under the heading Class II, for the entries in column (2) against the entries "Category 2 Radiographers" in column (1) thereof, the following entries shall be substituted, namely:-

"Director of Medical Education or Director of Medical and Rural Health Services or Director of Public Health and Preventive Medicine".
