ORDER:

The Secretary, Devendra Educational and Charitable Trust, Palayamkottai, Tirunelveli has requested the Government to grant permission to start four years B.Sc (Nursing) course with an annual intake of 60 seats in the name and style as “Almighty College of Nursing” at Thoothukudi Main Road, Ariyakulam Village, Tirunelveli

2. In Government letter seventh read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed nursing college has fulfilled the conditions prescribed by the Government in the Government Orders first to sixth read above and as per the norms of the Indian Nursing Council, New Delhi.

3. In his letter eighth read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government as well as by the Indian Nursing Council, New Delhi and recommend to grant permission to the Secretary, Devendra Educational and Charitable Trust, Palayamkottai, Tirunelveli to start four years B.Sc (Nursing) course with an annual intake of 60 seats in the name and style as "Almighty College of Nursing" at Thoothukudi Main Road, Ariyakulam Village, Tirunelveli.

4. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education and grant permission to the Secretary, Devendra Educational and Charitable Trust, Palayamkottai, Tirunelveli to start four years B.Sc (Nursing) course with an annual intake of 60 (sixty) seats in the name and style as "Almighty College of Nursing" in S.F.Nos. 309/2, 310/1 and 310/2A at Thoothukudi Main Road, Ariyakulam Village, Tirunelveli – 627 351, subject to fulfill the following specific conditions along with other general conditions laid down in G.O (Ms) No.219, Health and Family Welfare (PME.2) Department, dated: 06.06.2018 as applicable to this proposal before admitting the students:-

- i. The Trust should obtain building plan approval from the Directorate of Town and Country Planning (DTCP) for the proposed both boys and girls hostel building.
- ii. The Trust should construct its 100 bedded own parent hospital within a period of 8 months as mentioned in the undertaking submitted by the Trust.
- iii. The Trust should ensure availability of teaching faculty as per the INC norms.
- iv. The Trust should obtain recognition / affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai and the Tamil Nadu Dr. M.G.R. Medical University and if needed, suitability from Indian Nursing Council, New Delhi, respectively.

5. The Director of Medical Education is directed to take necessary further action accordingly.
