### ORDER:

In the letter read above, The Mission Director, National Health Mission has stated that the Government of India have sanctioned grants for National Health Mission in Record of Proceedings 2018 – 2019 and the same had been placed in 35<sup>th</sup> Executive Committee and got approval. The Government of India have also Released the Grants-in-Aid for Other Health System covered under National Urban Health Mission Programme also during 2018-19 and credited into State Government account as detailed below:-

The corresponding 40% of the State share against the 60% of the Government of India share of Rs.1,97,00,000/- (Rupees One crore and ninety saeven lakh only) works out of Rs.1,31,33,333/- (Rupees One crore thirty one lakh thirty three thousand three hundred and thirty three only).

2. The Mission Director, National Health Mission has therefore requested the Government to issue orders for the release of a sum of Rs.3,28,33,333/- (Rupees Three crore twenty eight lakh thirty three thousand three hundred and thirty three only) being the State and Central Share contribution of Grants-in-Aid for Other Health System covered under National Urban Health Mission during the year 2018-19 as mentioned above and to authorize him to draw the above amount under National Health Mission through Treasury mode and credit it into National Health Mission Account.

3. The Mission Director, National Health Mission has also requested the Government to re-appropriate a sum of Rs.3,18,33,333/- (Rupees Three crore twenty eight lakh thirty three thousand three hundred and thirty three only) from the Head of Account "2211 00 793 UA 09 31" (SCSP) to 2211 00 793 UC 09 37(SCSP) and Rs.10,00,000/-(Rupees Ten Lakh Only) from the Head of Account "2211 00 103 UA 09 32" (General) to 2211 00 794 UC 09 35 (STSP).

4. The amount sanctioned in para 4 above shall be debited to following heads of account:-

5. The Government after careful consideration have decided to accept the above proposal of the Mission Director, National Health Mission and accordingly issue order as follows:

- i. A sum of Rs.3,28,33,333/- (Rupees Three crore twenty eight lakh thirty three thousand three hundred and thirty three only) being the State and Central Share contribution of Grants-in-Aid for Other Health System covered under National Urban Health Mission during the year 2018-19 is sanctioned to the Mission Director, National Health Mission.
- ii. The Mission Director, National Health Mission is permitted to re-appropriate a sum of Rs.3,18,33,333/- (Rupees Three crore twenty eight lakh thirty three thousand three hundred and thirty three only) from the Head of Account 2211 00 793 UA 09 03 (SCSP) to 2211 00 793 UC 09 03(SCSP) and Rs.10,00,000/- (Rupees Ten Lakh Only) from the Head of Account 2211 00 103 UA 09 03 (General) to 2211 00 794 UC 09 03 (STSP).

6. The Mission Director, National Health Mission / Project Director, Reproductive and Child Health Project, Tamil Nadu is authorized to draw the amount sanctioned in para 4 above and to credit it into National Health Mission Account.

7. Necessary funds will be provided in the RE/FMA 2018 – 19, pending provision of such funds in the RE/FMA 2018-19, by the way of Re-appropriation from the Head of Account 2211 00 793 UA 09 03 (SCSP) and 2211 00 103 UA 09 03 (General) the Mission Director/ State Health Society / Reproductive Child Health is authorized to draw and disburse the amount sanctioned at para 5(i) above. The Mission Director/ State Health Society / Reproductive Child Health is requested to include this expenditure while sending the budget proposals for RE/FMA 2018 – 19 to Government in Finance (Health-I) Department without fail.
