- 2. The corresponding 40% of the State share against the 60% of the Government of India share of Rs.14,31,17,000/- (Rupees Fourteen crore thirty one lakh and seventeen thousand only) works out of Rs.9,54,11,333/- (Rupees Nine crore fifty four lakh eleven thousand three hundred and thirty three only).
- 3. The Mission Director, National Health Mission has therefore requested the Government to issue orders for the release of a sum of Rs.9,54,11,333/-(Rupees Nine crore fifty four lakh eleven thousand three hundred and thirty three only) being the State Share contribution of Grants-in-Aid to the 3rd Installment Infrastructure Maintenance under National Rural Health Mission for the year 2018 2019 as mentioned above and to authorize him to draw the above amount under National Health Mission through Treasury mode and credit it into National Health Mission Account.
- 4. The Mission Director, National Health Mission has also requested the Government to re-appropriate a sum of Rs. 42,53,333/- from the Head of Account 2211 00 103 UA 09 32 (General) to Head of Account 2211 00 794 UA 09 39 (STSP).
- 5. The Government after careful consideration have decided to accept the above proposal of the Mission Director, National Health Mission and accordingly order as follows:
 - i. a sum of Rs.9,54,11,333/- (Rupees Nine crore fifty four lakh eleven thousand three hundred and thirty three only) being the State Share contribution of Grants-in-Aid to the 3rd Installment Infrastructure Maintenance under National Rural Health Mission for the year 2018 2019 is sanctioned to the Mission Director, National Health Mission.
 - ii. a sum of Rs.42,53,333/- (Rupees Forty two lakh fifty three thousand three hundred and thirty three only) is re-appropriated from General head 09 03 (DPC 2211 00 103 UA 09 32) (General) to STSP head 09 03 (DPC 2211 00 794 UA 09 39) (STSP)
