### **ORDER :**

In Government Order 1<sup>st</sup> read above, orders have been issued for apportionment of seats between Government and Managements of Unaided, Non Minority and Minority Medical / Dental / Paramedical / Indian System of Medicine Colleges for the admission in both Under Graduate and Post Graduate courses for the academic year 2007-2008 as follows:

<b>Nature of the Institution</b>	<b>Government</b>	<b>Management</b>
Non-Minority Institutions	65%	35%
Minority Institutions	50%	50%

The same apportionment of seats has been followed in the subsequent years and for the academic year 2014 – 2015, orders were issued in G.O. 2<sup>nd</sup> read above in respect of Post Graduate admission.

2. The Government, as requested by the Director of Medical Education (OSD) / Secretary, Selection Committee, Chennai in his letter 3<sup>rd</sup> read above have examined the question of apportionment of seats between Government and Management of Unaided, Minority / Non-Minority Medical / Dental / Para Medical / Indian System of Medicine Colleges in the State for the admission of Post Graduate Courses for the academic year 2015 - 2016.

3. The Government after careful consideration direct that the same apportionment ratio i.e., 65 : 35 and 50 : 50 fixed between Government and

Management of Unaided, Non Minority and Minority, Medical / Dental / Paramedical/ Indian System of Medicine Colleges in Tamil Nadu as ordered in G.O. 1<sup>st</sup> read above and as indicated in para 1 above shall be followed in admission to Post Graduate Courses in Unaided Medical / Dental / Para Medical / Indian System of Medicine Colleges for the academic year 2015 – 2016, in accordance with the Tamil Nadu Admission in Professional Educational Institutions Act, 2006.

4. The Director of Medical Education is directed to take action accordingly.
