### ORDER:-

The Tamil Nadu Government Medical Department Engineers Association in their letter first read above, has stated among others that the Assistant Executive Engineer (Equipments and Maintenance) will have overall control of the entire engineering wing of the Medical College and Hospitals such as, Steam Laundry, Central Sterilization Service Department (CSSD), Central Workshop Refrigeration Section, Electronic Exchange, Central Section Plants, Lifts, Generators, Modern Kitchen, Solar Water heaters and in charge of Central Workshop etc., All Electrical and Mechanical Maintenance works executed by the Public Work Department should be routed through the Assistant Executive Engineers (Equipment and Maintenance). The Association has also stated that the duties and responsibilities attached to the post of Junior Engineer (Steam Laundry/Mechanical) will be added to the duties and responsibilities of Assistant Executive Engineer post, if the posts of Junior Engineer (Steam Laundry/Mechanical) in the Medical Institutions may be upgraded as Assistant Executive Engineer (Equipment & Maintenance). In fine, the Association has requested to upgrade the posts of Junior Engineer (Steam Laundry/Mechanical) in the Medical Institutions as Assistant Executive Engineer (Equipment & Maintenance).

2. The Director of Medical Education in his letter second read above, has stated among others that the request of the Government Medical Department Engineers Association to upgrade the posts of Junior Engineer (Steam Laundry) post into Assistant Executive Engineer (Equipment & Maintenance) is genuine and requested the Government to issue suitable orders to upgrade the post of Junior Engineer (Steam Laundry) in the revised scale of pay of (level-13) Rs.35900-1,13,500 into that of Assistant Executive Engineer (Equipment & Maintenance).

Further he has furnished the seniority list of 17 candidates in the post of Junior Engineer (Steam Laundry).

3. The Government have examined the proposal of the Director of Medical Education in detail and decided to upgrade the 7 posts of Junior Engineer (Steam Laundry/Mechanical) along with the candidates in the following Institution as Assistant Executive Engineer (Equipment & Maintenance).

The Government accordingly, do and hereby direct that the posts held by the above said 7 candidates in the post of Junior Engineer (Steam Laundry/Mechanical) of the Institution mentioned against their names be upgraded as Assistant Executive Engineer (Equipment & Maintenance) at a cost of Rs.21,26,376 per annum. The Director of Medical Education is also directed to fix the pay of the individual in the upgraded post (in the revised scale of pay of (level -22) Rs.56100 – 1,77,500 from the date of issue of this order.

4. The expenditure towards pay and allowances for the posts shall be debited to the head of account as mentioned in the annexure to this order.
