ORDER:

In Government Order fourth read above, permission was accorded to the Managing Trustee, Apollo Hospitals Educational Trust, Chennai to start a College of Nursing in the name and style as "Madurai Apollo College of Nursing" to conduct B.Sc (Nursing) course at Elliyarpathi Village, Madurai South Taluk, Madurai District with an annual intake of 50 students from the academic year 2009-2010.

- 2. The Managing Trustee, Apollo Hospitals Educational Trust, Chennai has requested the Government to grant permission to enhance the seats in B.Sc Nursing course from 50 to 100 at Madurai Apollo College of Nursing, Elliyarpathi Village, Thiruparankundram Union, Madurai South Taluk, Madurai.
- 3. In Government letter eighth read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed nursing school has fulfilled the conditions prescribed by the Government in the Government Orders first to third and fifth to seventh read above and as per the norms of the Indian Nursing Council, New Delhi.
- 4. In his letter nineth read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government as well as by the Indian Nursing Council, New Delhi and recommended to grant permission to the Managing Trustee, Apollo Hospitals Educational Trust, Chennai to enhance the seats in B.Sc Nursing course from 50 to 100 at Madurai Apollo College of Nursing, Elliyarpathi Village, Thiruparankundram Union, Madurai South Taluk, Madurai.
- 5. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education. The Government hereby grant permission to the Managing Trustee, Apollo Hospitals Educational Trust, Chennai to enhance the seats in B.Sc (Nursing) course from 50 to 100 (fifty to hundred) at Madurai Apollo College of Nursing in R.S. Nos.11/1 and 11/2B, Patta No.916, Elliyarpathi Village, Thiruparankundram Union, Madurai South Taluk, Madurai-625 022, subject to the condition that the Trust should obtain recognition / affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai and the Tamil Nadu Dr. M.G.R. Medical University and if needed, suitability from Indian Nursing Council, New Delhi, respectively along with other general conditions laid down in G.O (Ms) No.219, Health and Family Welfare (PME.2) Department, dated: 06.06.2018 as applicable to this proposal before admitting the students.
- 6. The Director of Medical Education is directed to take necessary further action accordingly.
