#### ORDER:

The Chairman, A.R. Educational and Charitable Trust, Tenkasi District has requested the Government to grant permission to start four years B.Sc (Nursing) course with an annual intake of 60 seats in the name and style as “A.R. College of Nursing” at AR Nagar, Kadayam, Tenkasi District.

2. In Government letter seventh read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed nursing school has fulfilled the conditions prescribed by the Government in the

Government Orders first to sixth read above and as per the norms of the Indian Nursing Council, New Delhi.

3. In his letter eighth read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government as well as by the Indian Nursing Council, New Delhi and recommended to grant permission to the Chairman, A.R. Educational and Charitable Trust, Tenkasi District to start four years B.Sc (Nursing) course with an annual intake of 60 seats in the name and style as "A.R. College of Nursing" at AR Nagar, Kadayam, Tenkasi District.

4. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education. The Government hereby grant permission to the Chairman, A.R. Educational and Charitable Trust, Tenkasi District to start four years B.Sc (Nursing) course with an annual intake of 60 (sixty) seats in the name and style as "A.R. College of Nursing" in the existing building of A.R. College of Engineering and Technology in S.F. Nos. 164/7A2, 165/1165/2, 166/3A1, 166/3A2, in AR Nagar, Therkkumadathur, Kadayam, Tenkasi District – 627 423, subject to fulfill the following specific conditions along with other general conditions laid down in G.O (Ms) No.219, Health and Family Welfare (PME.2) Department, dated: 06.06.2018 as applicable to this proposal before admitting the students:-

- i. The Trust should obtain conversion of building plan approval from the DTCP for A.R. College of Nursing.
- ii. The Trust should obtain building plan approval from the DTCP for Boys and Girls Hostel building.
- iii. The Trust should ensure availability of teaching faculty as per the INC norms.
- iv. The Trust should obtain recognition / affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai and the Tamil Nadu Dr. M.G.R. Medical University and if needed, suitability from Indian Nursing Council, New Delhi, respectively.

5. The Director of Medical Education is directed to take necessary further action accordingly.
