#### ORDER:

In the Government Order first read above, the adhoc rules for the Post of Audiometrician was issued. The post of Audiometrician is necessary for smooth functioning of the ENT Department in the Hospitals. To diagnose the ear problem of the patients, the services of the Audiometrician is very essential. Without the Audiometrician, proper treatment could not be given to the patients. The Board of Para Medical Education under the control of the Director of Medical Education has since conducted various Para Medical Courses in Government Medical Colleges by which best services can be provided to the people. Therefore to make use of the best trained personnel in the posts of Audiometrician in Government Medical College Hospitals, the following amendment is issued to the Adhoc Rules for the post of Audiometrician.

The following Notification will be published in the Tamil Nadu Government Gazette:-

#### NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the constitution of India, the Governor of Tamil Nadu hereby makes the following Amendments to the Adhoc Rules published with the erstwhile Health, Education and Local Administration Department Notification S.R.O. No. A.3530 of 1959, dated the 27<sup>th</sup> May 1959, at pages 841 and 842 of Part I of the Fort St. George Gazette, dated the 17<sup>th</sup> June 1959, as subsequently amended.

2. The amendments hereby made shall come into force on the date of Publication of this Notification in the Tamil Nadu Government Gazette.

## AMENDMENTS.

In the said Rules,-

(1) for rule 5, the following rule shall be substituted, namely:-

"5. Qualification.- (a) Age.- No person shall be eligible for appointment to the post by direct recruitment, if he has completed or will complete 30 years of age on the first day of July of the year in which the selection for appointment is made.

(b) Other Qualification.- No person shall be eligible for appointment to the post unless he possesses the following qualification, namely:-

- i. Must have passed HSC with Subjects Physics, Chemistry, Botany and Zoology or Physics, Chemistry, Biology with any one of the related subjects;
- ii. Must have passed a one year certificate course in Audiometry from Government Medical Institutions under the control of the Director of Medical Education or in any other institution recognized by the State or Central Government";

(2) rule 6 shall be omitted.

(3) In rule 7, the following proviso shall be added namely:-

"provided further that on and from the first January 2006 the monthly pay shall be calculated in the scale of pay Rs.5200-20,200+GP of Rs.2400/-"

(4) after rule 7, the following rule shall be added, namely:-

**"8. Saving Clause**.- Nothing contained in these rules shall adversely affect any person holding the post as on 6.01.2015."
