From the Director of Public Health and Preventive Medicine, Letter No.156086/PHC6/A3/2003, dated 01.07.2009, 25.04.2013 and 15.07.2013.

ORDER:

The Director of Public Health and Preventive Medicine has stated that the Primary Health Centres and Health Sub-Centres are providing the necessary health services to the rural population. Earlier Rural Development and Panchayat Raj Department used to run similar centres. However, Government has been converting them as Primary Health Centres in a phased manner. So far, out of 163 such health facilities with Rural Development and Panchayat Raj Department, 99 Panchayat Union Dispensaries have already been converted as Primary Health Centres and 64 Panchayat Union Dispensaries (List in Annexure-I) are remaining.

2. The Director of Public Health and Preventive Medicine has now sent a proposal for conversion of the 8 Panchayat Union Dispensaries as Primary Health Centres and to utilize the building of 7 Panchayat Union Dispensaries as Health Sub Centres along with the staff pattern of a Primary Health Centre and salary component as detailed below:

- 3. The Director of Public Health and Preventive Medicine has also requested to absorb the 98 staff already working in the above 64 Panchayat Union Dispensaries into the Public Health Department. Accordingly, the Government issues the following orders:

^{5.} The expenditure sanctioned in para 3 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will initially be met by an advance from the Contingency Fund and orders regarding which will be issued by the Finance (BG-I) Department separately. The Director of Public Health and Preventive Medicine is requested to send application in the prescribed form along with a copy of this order to Finance (BG-I) Department for sanctioning the advance. The Director of Public Health and Preventive Medicine is also requested to send necessary explanatory note for inclusion of the expenditure in the Supplementary Estimate to obtain approval of the Legislature to the Finance (Health–I / BG-I) Department at the appropriate time for 2014-15.

- 6. The Rural Development and Panchayat Raj Department is directed to discontinue the practice of starting new Panchayat Union Dispensary / revive the Panchayat Union Dispensary / recruit to the vacancies of the above Panchayat Union Dispensaries.
- 7. The Director of Public Health and Preventive Medicine is directed to send separate proposal for fixing seniority of the candidates so absorbed.
- 8. This order issues with the concurrence of Finance Department vide its U.O. No.11347/CMPC, dated 27.02.2015 and ASL No.2578 (Two thousand five hundred and seventy eight).
