ORDER:

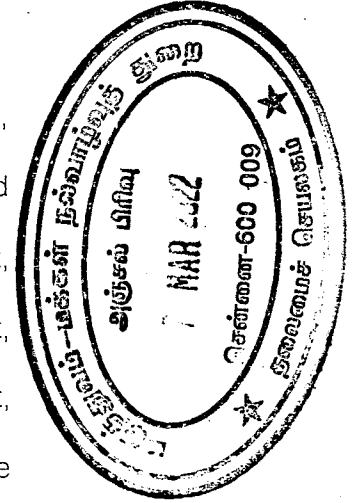
In the Government Order first read above, various categories of Unipurpose Health Workers were absorbed as Multipurpose Health Assistant and Multipurpose Health Supervisor for implementation of the Multipurpose Health Worker Scheme. The actual implementation of the Government Order came into effect on 04.11.1988.

2) In the Government Order second read above, among other things, the adhoc rules were framed for the posts of Multipurpose Health Assistant and Multipurpose Health Supervisor.

3) In the Government Order third read above, the Government have re-organized the male component in which the post of Multipurpose Health Assistant and Multipurpose Health Supervisor were re-designated as Health Inspector Grade-II and Health Inspector Grade-I respectively. Accordingly the adhoc rules were also amended in the Government Order fourth read above.

4) In the Government Order fifth read above, the nomenclature of the posts, appointing authority, age, other qualification, method of appointment, transfer and posting and other amendments have been issued to the adhoc rules.

5) Now, by considering the demands of various associations and based on the announcement made by the Minister for Health and Family Welfare in the floor of the Assembly, the Government have decided to change the nomenclature of the posts of Multipurpose Health Worker (Male) and Multipurpose Health Supervisor (Male) as Health Inspector Grade-II and Health Inspector Grade-I to indicate more specifically according to the scheme assigned to the post.
