## ORDER:

The Principal Secretary / Commissioner of Indian Medicine and Homoeopathy has stated that the M.D. (Homoeopathy) course is being conducted from the academic year 2010-2011 only in Self Financing Institution namely Saradhakrishna Homoeopathy Medical College, Kulasekaram, Kanniyakumari District. The sanctioned strength for MD (Homoeopathy) course in the college is 30. This institution is a Minority institution. Hence, 50% of the seats to be filled up by the Government as per the Government Order first read above.

- 2. Based on the request of the Principal Secretary / Commissioner of Indian Medicine and Homoeopathy second read above, the Government approve the Prospectus, Application form, Notification etc., in connection with the admission of students for Post Graduate Course in MD (Homoeopathy) course 2015-16 session.
  - i) The cost of application shall be fixed at Rs.2,000/- (Rupees Two thousand only)
  - ii) Applications can be issued to candidates through Tamii Nadu Health Department website on par with allocathy side.
  - iii) The Entrance Examination will be conducted for 3 hours as in the case of MD (Siddha).
  - iv) Candidates belonging to SC/SCA and ST community shall be exempted from paying the cost of application as per G.O.Ms.No.111/ADWTD/Dept., dated 22.09.1998.

- v) To follow the rule of reservation for filling up of the seats in Post Graduate MD (Homoeopathy) course for the academic year 2015-16 session duly adopting roaster Method of reservation since each branch has only less than eight seats.
- vi) Minimum eligibility marks for admission shall be fixed as follows:

For O.C., B.C., B.C(Muslim), M.B.C/DC candidates : 40%

For SC/SCA/ST candidates : 35%

For Service candidates (irrespective of all Communities) : 35%

- vii) The total marks for MD (Homoeopathy) Entrance Examination shall be fixed as 100 (for Written 90 Marks + Experience = 10 marks).
- viii) The Principal Secretary and Commissioner of Indian Medicine and Homoeopathy is permitted to publish the MD (Homoeopathy) Entrance Examination 2015 -2016 session results.
- ix) The printing of MD (Homoeopathy) Entrance Examination Question papers shall be entrusted to Confidential Press / any press without inviting any tender / quotation.
