ORDER:

In the Government Order first read above, the Government have accorded administrative and financial sanction for a sum of Rs.7,30,00,000/- for the construction of Residential Quarters (Teaching and Non-Teaching Staff) and Rs.3,12,50,000/- for the construction of Residential Quarters for 85 Doctors at K.A.P.Viswanatham Government Medical College attached to Mahatma Gandhi Memorial Government Hospital, Trichy.

2. The Engineer-in-Chief and Chief Engineer (Buildings), Public Works Department, Chennai has sent the revised administrative sanction proposal for the construction of Residential Quarters (Teaching and Non-Teaching Staff) for a sum of Rs.7,53,34,600/- and for the construction of Residential Quarters for 85 Doctors for a sum of Rs.3,22,43,578/- at K.A.P.Viswanatham Government Medical College attached to Mahatma Gandhi Memorial Government Hospital, Trichy due to tender excess and other charges, the details of which are as follows:-

3. The Director of Medical Education has stated that the revised estimate is due to tender excess and excess in tender advertisement charges. She has therefore, requested the Government to accord revised administrative sanction for a sum of Rs.7,53,34,600/- for the construction of Residential Quarters (Teaching and Non-Teaching Staff) and Rs.3,22,43,578/- for the construction of Residential Quarters for 85 Doctors at K.A.P.Viswanatham Government Medical College attached to Mahatma Gandhi Memorial Government Hospital, Trichy. She has countersigned and forwarded the revised estimate received from the Engineer-in-Chief and Chief Engineer (Buildings), Public Works Department, Chennai.

4. The proposal has been cleared by Technical Advisory Committee constituted in G.O.(Ms) No.146, Public Works Department, dated 12.08.2011 to scrutinize the revised administrative sanction proposal in respect of all technical and financial aspects involved in the work and the Tender Award Committee in its 206th meeting on 13.08.2014 has approved the revised administrative sanction proposal as detailed below with an instruction that there should not be any further revised administrative sanction and subject to accuracy, correctness and genuineness of all informative data furnished by the Chief Engineer (Buildings), Public Works Department, Trichy:-

5. The Government have examined the proposal of the Director of Medical Education and decided to accept the same. Accordingly, the revised administrative sanction is accorded for a sum of Rs.7,53,34,600/- (Rupees Seven Crore Fifty Three Lakh Thirty Four Thousand and Six Hundred only) for the construction of Residential Quarters (Teaching and Non-Teaching Staff) as against the original sanction of Rs.7,30,00,000 and Rs.3,22,43,578/- (Rupees Three Crore Twenty Two Lakh Forty

Three Thousand Five Hundred and Seventy Eight only) for the construction of Residential Quarters for 85 Doctors, as against the original sanction of Rs.3,12,50,000/- at K.A.P.Viswanatham Government Medical College attached to Mahatma Gandhi Memorial Government Hospital, Trichy i.e., total additional expenditure sanctioned is Rs.33,28,178/-.

6. The expenditure sanctioned in para 5 above shall be debited to the following head of account:-

“4210 – Capital Outlay on Medical and Public Health – 01 Urban Health Services – 110 Hospitals and Dispensaries (including Pharmacy) – Schemes in the Twelfth Five Year Plan II – State Plan – JA Buildings – 16 Major works”.

7. Necessary funds will be provided in Final Modified Appropriation 2014-2015. Pending provision of such funds in Final Modified Appropriation 2014-2015, the Chief Engineer (Buildings) is authorized to draw and utilize the amount sanctioned in para 5 above. However, this expenditure will be brought to the notice of the Legislature by specific inclusion in the Supplementary Estimate 2014-2015. The Chief Engineer (Buildings) is directed to include the item of expenditure while sending the proposal for Final Modified Appropriation 2014-2015 and send necessary draft explanatory notes for inclusion of the expenditure in the Supplementary Estimate 2014-2015 to the Government in Finance Department without fail.

8. This order issues with the concurrence of Finance Department vide its U.O.No.8308/Health-II/2015, dated 24.02.2015 and ASL No.2612 (Two Thousand Six Hundred and Twelve).
