ORDER:

In Government order 2nd read above, Administrative Sanction was accorded to carry out civil works for upgrading 9 Primary Health Centres under National Health Mission at a total cost of Rs.1080.00 lakh through Public Works Department and sanction was accorded for an amount of Rs.216.00 lakh for civil works being 20% of total cost approved by Government of India.

- 2. The Mission Director, State Health Society in the letter 3rd read above has stated that now in Record of Proceedings 2017-18, the Government of India has approved a sum of Rs.216.00 lakh for civil works of 9 Upgraded Primary Health Centres being 20% of the total requirement of Rs.1080.00 lakh.
- 3. The Mission Director, State Health Society has also stated that as per the orders issued in Government order 1st read above, a sum of Rs.216.00 lakh approved by Government of India in Record of Proceedings 2017-18 has been remitted into Government of Tamil Nadu account vide challan No. 427, dated 08.08.2017.
- 4. The Mission Director, State Health Society has therefore requested Government order in this regard.
- 5. After careful examination, the Government have decided to accept the proposal of Mission Director, State Health Society and accordingly issue the following orders:-
- i) sanction is accorded for a sum of Rs.2,16,00,000/-(Rupees Two crore sixteen lakh only) for execution of civil works (upgradation of 9 Primary Health Centres) being 20% of total cost approved by Government of India to Public Works Department, in addition to the funds of Rs.2,16,00,000/- (Rupees Two crore sixteen lakh only) sanctioned in Government order 1st read above.

- ii) the Mission Director, State Health Society is directed to send the proposal to Government of India to avail balance fund of Rs.648.00 lakh (Rs.120.00 lakh x 60% x 9 upgradation Primary Health Centres) required for the civil works, Human Resources and other components in the subsequent Programme Implementation Plans and remit the amount into Government account under receipt head, as and when it is approved by Government of India, as per the existing procedure under National Health Mission.
- iii) the Engineer-in-Chief and Chief Engineer (Buildings), Public Works Department, Chennai is permitted to issue orders to the Executive Engineers of the concerne divisions for the drawal of funds.
- 6. The Expenditure sanctioned in para 5(i) above shall be debited to the following Head of account:-

"4211 - 00 - Capital Outlay on Family Welfare -103 Maternity and Child Health — Central sector schemes — SA National Component — Reproductive and Child Health Project — 16 Major works".

- 7. Necessary funds are provided in Revised Estimate 2017-2018. The Chief Engineer and Engineer-in-Chief(Buildings) is authorized to incur the amount sanctioned in para 5(i) above.
