ORDER:

The Mission Director, State Health Society in his letter read above has stated that the Government of India have informed that the transfer of Central funds under the Centrally sponsored Schemes like National Health Mission is being made through the Treasury route as part of the State plan and requested to provide for Central Share of National Health Mission in the State Budget. The Government of India have transferred its 75% of Central Government Share as Grants –in –aid and credited a sum of Rs.42,29,000/- into State Government account for the financial year 2014-15 for the implementation of the programmes National Programme for Prevention and Control of Deafness(NPPCD) for the year 2014-15 as detailed below:

Government of India have requested to ensure 25% State contribution based on the release of funds by Government of India.

2. The Mission Director, State Health Society has further stated that the corresponding 25% of the State Share against the 75% of the Government of India release of Rs.42,29,000/- (Rupees Forty two lakh and Twenty nine thousand only) works out to Rs.14,09,667/- (Rupees Fourteen lakh nine thousand six hundred and sixty seven only). Hence, in order to implement the scheme under above said

programmes during 2014-15, he has requested to issue orders for the release of a sum of Rs.56,38,667/- (Rupees Fifty six lakh thirty eight thousand six hundred and sixty seven only) towards Central and State contribution of Grants- in- aid to the State Health Society, Tamil Nadu under National Programme for Prevention and Control of Deafness (NPPCD) under Non Communicable Disease (NCD) Flexipool of National Health Mission during 2014-15 as mentioned above and to authorize the Mission Director, State Health Society / Project Director, Reproductive and Child Health Project, Tamil Nadu to draw a sum of Rs.56,38,667/- (Rupees Fifty six lakh thirty eight thousand six hundred and sixty seven only) and to incur expenditure under National Programme for Prevention and Control of Deafness(NPPCD)..

3. The Government, after careful consideration, have decided to accept the proposal of the Mission Director, State Health Society and they accordingly sanction for the release of a sum of Rupees 56,38,667/- (Rupees Fifty six lakh thirty eight thousand and six hundred and sixty seven only) 75% of Government of India release of Rs.42,29000/- and 25% of State Share of Rs.14,09,667/- under National Programme for Prevention and Control of Deafness(NPPCD) under Non Communicable Disease(NCD) Flexipool of National Health Mission during 2014-15.
