ORDER:

During the budget session held on 12.08.2014, the Hon'ble Chief Minister of Tamil Nadu has announced under rule 110 that,

"Rs.6.00 crores will be allotted for construction of Hostel building for P.G. students at Madras Medical College, Chennai".

- 2. Based on the above announcement, the Director of Medical Education has sent proposal for the construction of hostel buildings at Madras Medical College, Chennai, as detailed below, at a total estimated cost of Rs.600.00 lakhs for the year 2014-2015 and Rs.660.00 lakhs for the year 2015-2016 assuming an escalation of 10%, along with the rough cost estimates approved by the Engineer in Chief and Chief Engineer (Buildings), Chennai, duly countersigned by the Director of Medical Education, Chennai.
- 3. The Director of Medical Education has therefore, requested the Government to accord administrative and financial sanction for a sum of Rs.600.00 lakhs for the year 2014-2015 and Rs.660.00 lakhs for the year 2015-2016 by adding 10% escalation of costs, for the construction of hostel buildings at Madras Medical College, Chennai, as detailed below:-

- 4. The Government have examined the proposal of the Director of Medical Education in detail and accord administrative and financial sanction for a sum of Rs.6.00 Crore (Rupees six crore only) for the year 2014-2015 and Rs.6.60 Crore (Rupees six crore and sixty lakhs only) for the year 2015-2016 by adding 10% escalation of costs, for the construction of hostel buildings for P.G. Students at Madras Medical College, Chennai.
- 5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:-

"4210-Capital Outlay on Medical and Public Health – 01- Urban Health Services – 110 – Hospitals and Dispensaries (Including Pharmacy) – Schemes in the Twelfth Five Year Plan- II- State Plan – JA Buildings – 16 Major Works" (D.P.C. 4210-01-110-JA-1602)".

6. The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and the approval of legislature will be obtained in due course. Pending approval of legislature the expenditure will be initially met by an advance from the Contingency Fund will be issued by the Finance (BG-I) Department. The Chief Engineer (Buildings) shall apply for sanction of advance from Contingency Fund for the required amount in the prescribed format along with a copy of this order to Finance (BG-I)

Department. The Chief Engineer (Buildings) shall also send necessary explanatory notes to include the above expenditure in the Supplementary Estimate for the year 2014-2015 to Finance Department at the appropriate time without fail.
