ORDER:

In the letters second read above, the Director of Public Health and Preventive Medicine has stated that the Office of the Deputy Director of Health Services, Kallakurichi is functioning in a private rented building for a long time. The rent was enhanced from Rs.9900/- to Rs.11,374/- with effect from 01.03.2010. He has requested the Government to issue sanction orders for enhancement of payment of rent from 11,374/- to Rs.13,080/- per month to the Deputy Director of Health Services, Kallakurichi for the period from 01.03.2013 to 28.02.2014.

- 2. As per the orders issued in G.O.(Ms).No. 1352, Public Works Department, dated 17.09.1993, fifteen percent of the rent of the Private Buildings, where Government offices are functioning, can be enhanced once in three years.
- 3. The Government have carefully examined the above said proposal of the Director of Public Health and Preventive Medicine. Accordingly, the Government fix the rent for the private building wherein the office of the Deputy Director of Health Services, Kallakurichi, is function as Rs.13080/per month from 01.03,2013 to 28.02.2014.
