ORDER:

In the G.O. first read above, orders were issued giving time bound promotion to the Medical Officers working in the Health and Family Welfare Department. Subsequently, in Government Order second read above, certain clarifications were issued to the Government Order first read above that the Assistant Surgeon Medical Officers working in the Tamil Nadu Medical Service of all the Directorates shall be given time bound promotion on completion of 8, 15, 17 years of eligible service in the designation/scales of Senior Assistant Surgeon Pay Band-III Rs.15600 – 39100 + Grade Pay of Rs.5700/-, Civil Surgeon Pay Band-III Rs.15600 – 39100 + Grade Pay of Rs.6600/- and Senior Civil Surgeon Pay Band-III Rs.15600 – 39100 + Grade Pay of Rs.7600/- respectively and on completion of 20 years of eligible service as Chief Civil Surgeon in Pay Band-IV Rs.37400 – 67000 + Grade Pay of Rs.8700/-.

- 2. In the Government letter third read above, the date of effect of G.O. second read above has been given prospective effect from the date of issue of the order 30.10.2013.
- 3. In order to settle the legal issues raised by the Medial Officers belonging to Tamil Nadu Medical Service and also clarify the ambiguity regarding the date of implementation of the time bound promotions, the Government hereby issue the following amendment to the orders issued in the reference fourth read above.

AMENDMENT

For the entries made in paragraph 5 (i) in the order fourth read above, the following entries shall be substituted:

- i. To give effect to the .G.O.(Ms)No.245, Health and Family Welfare Department, dated 30.10.2013, for getting time bound promotion with monetary benefits to the Medical Officers who have completed 8 / 15 / 17 / 20 years before 23.10.2009 in the post of Senior Assistant Surgeons / Civil Surgeons / Senior Civil Surgeons / Chief Civil Surgeons respectively prior to 23.10.2009 they shall be granted promotion with monetary benefit with effect from 23.10.2009 only i.e. the date of issue of G.O. (Ms) No.354, Health and Family Welfare Department, dated 23.10.2009. In case of those who have completed the required service after 23.10.2009, they shall get the monetary benefit from the date of completion of 8/15/17/20 years in the cadre of Senior Assistant Surgeons / Civil Surgeons / Senior Civil Surgeons / Chief Civil Surgeons respectively.
- 4. This order issues with the concurrence of the Finance department vide its U.O.No.7395/PCII/2017, dated 16.02.2018.
