### ORDER:

The Director of Drugs Control (i/c) in his letter third read above, has stated that Thiru. J. Britto Periyanaayagam and Thiru S. The Director of Drugs Control has requested the Government that the names of Thiru. J. Britto Periyanaayagam and Thiru S. Kathiravan may be notified as Drugs Inspectors under Section 21 of Drugs and Cosmetics Act, 1940 for the purpose of carrying out inspections of manufacturing premises and sales of Drugs by the Drug Inspectors as per the Drugs and Cosmetics Act, 1940 for the State of Tamil Nadu.
