ORDER:-

In the Government Order first read above among others the Government issued order for the formation of Transplant. Authority of Tamil Nadu (TRANSTAN) and also directed the Dean, Rajiv Gandhi Government General Hospital, Chennai attached to the Madras Medical College to allocate a sum of Rs.25.00 lakh (Rupees Twenty Five Lakh only) from out of the incentive funds available under the Chief Minister's Comprehensive Health Insurance Scheme (CMCHIS) available with the Rajiv Gandhi Government General Hospital, Chennai attached to the Madras Medical College for the purpose of registration, establishment of the society and to provide infrastructure communication and related facilities, till the receipt of funding from the Government of India and also allocate sufficient space for the society.

- 3. As the Dean, Madras Medical college has expressed her inability to share the funds from Chief Minister's Comprehensive Health Insurance Scheme (CMCHIS), the Government in the Government Order second read above directed the Dean, Rajiv Gandhi Government General Hospital, Chennai and Stanley Hospital, Chennai to share the funds in the proportion of 50% each (Rs.12.50 lakh each) from out of the funds available under the Chief Minister's Comprehensive Health Insurance Scheme (CMCHIS) available to provide infrastructure facilities to TRANSTAN till the receipt of funds from Government of India.
- 4. In the letter third read above, the Dean, Government General Hospital, Chennai, has stated that the Government General Hospital, Chennai is taking care of terminal ill patients referred from various parts of the Tamil Nadu and neighboring States for specialists opinion. Madras Medical College is the only medical college in the country having the highest number of super specialty course. In view of multi super specialty hospital and to cater the needs of umpteen numbers of poor patients, huge expenditure in the form of consumables as well as other accessories are needed in a larger volume.

- 4. The Dean has further stated that they are meeting out all the expenditures incurred for the specialized services for large volume of patients from the Chief Minister Comprehensive Health Scheme only. And the funds generated through the CMCHIS is not sufficient for taking care of day to day services for the poor people coming to Government General Hospital. Further the Dean has stated that the funds of CMCHIS is deficit due to the more pending issues like infrastructure (civil and electrical) for insurance wards and procurement of day to day consumables and emergency drugs. Hence, it is not possible to share the funds from CMCHIS as requested for the setting up of the TRANSTAN as per the Government Order second read above.
- 5. The Transplant Authority of Tamil Nadu (TRANSTAN) will also function as Regional Organ and Tissue Transplant Organization (ROTTO) / State Organ and Tissue Transplant Organization (SOTTO).
- 6. Therefore the Government after careful examination decided to accept the proposal and accord sanction for a sum of Rs.25.00 lakhs to meet out the initial expenditure for establishment of TRANSTAN (Transplant Authority of Tamil Nadu).
 - 7. The above expenditure shall be debited to the following Head of Account:-
 - 2210 Medical and Public Health 01 Urban Health Services Allopathy 110 Hospitals and Dispensaries I Non–Plan DX Cadaver Transplant Programme 09. Grants –in-Aid 03 Grants for specific Schemes. (DPC: 2210-01-110-DX-0938)
- 8. The expenditure sanctioned in para 6 above shall constitute an item of "New Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Director of Medical Education is directed to calculate the actual amount required for the period upto next RBE 2016-2017 Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to finance (BG.I) Department directly in Form A appended to the Tamil Nadu contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Director of Medical Education is requested to send necessary proposal to include the above expenditure in the Supplementary Estimates for the year 2016-17 to Government in Finance (Health-II) Department at the appropriate time without fail.

9. This order issues with the concurrence of Finance Department vide its U.O.No. 19711/Health-II/2016, dated 10.05.2016 and ASL No.192 (One hundred and ninety two).
