The director of Family Welfare has stated that the above posts are very much essential to run the institutions. He has therefore requested the Government to

accord further continuance for the above posts for the period from 01.04.2016 to 30.09.2018 as detailed in the Annexure to this order.

- 2. The government have examined the proposal of the Director of Family Welfare carefully and decided to accept it. Accordingly, sanction is accorded for the further continuance of the temporary posts mentioned in the Annexure to this order for the period from 01.04.2016 to 30.09.2018.
- 3. The holders of these posts are eligible to draw pay and other allowance as admissible under rules in force from time to time.
