### ORDER:-

The Director of Medical Education in his letter read above has stated, among others, that the Government Coimbatore Medical College, Coimbatore was started in the late sixties with 3 Physiotherapists. Subsequently, the artificial limb sub centre was added in the year 1968. The Department became more organized with a Physiatrist (Physical Medicine and Rehabilitation Specialist) taking the leadership role for Medical Rehabilitation of the patients in the eighties. The details of the post sanctioned are as follows:-

He has also stated that the Physical Medicine and Rehabilitation Department is conducting outpatient services and the in-patients services regularly and provision of occupational therapy services is essential and will improve the functional status of the patient to a big extent. For the Department of Physical Medicine and Rehabilitation, various posts of allied health staff like Physiotherapists, Speech Therapists, etc. are required as per the MCI norms. Out of these, 2 posts of the Occupational Therapists are necessary to run the department. He has, therefore, requested the Government to accord sanction for creation of one post of Occupational Therapist Grade-II at an average cost Rs.10.30 lakh per annum to the Department of Physical Medicine and Rehabilitation to Coimbatore Medical College Hospital, Coimbatore.

- 2. The Government have examined the proposal of the Director of Medical Education in detail and decided to sanction one post of Occupational Therapist Grade-II, Minimum Pay of Rs. 35,400/- (Level 11, Rs. 35,400-1,12,400) to the Department of Physical Medicine and Rehabilitation to Coimbatore Medical College Hospital, Coimbatore. Accordingly, the Government do and hereby direct that one post of Occupational Therapist. Grade-II be created at an average cost of Rs.10.30 lakh per annum (Rupees Ten lakh and thirty thousand only).
- 3. The expenditure towards pay and allowances of the post sanctioned para 3 above shall be debited to the following head of account:-

"2210-Medical and Public Health – 01 – Urban Health Services – Allopathy – 110 – Hospitals and Dispensaries – State's Expenditure – DI – Government Coimbatore Medical College Hospital, Coimbatore- 01 - Salaries. (DP code 2210-01-110-DI-0107)"
