### ORDER :

In the Government Order first read above, orders have been issued among others permitting the Director of Public Health and Preventive Medicine to establish the Hospital on Wheels Programme utilizing the 385 mobile medical units sanctioned under National Health Mission and accorded sanction for the appointment of 385 Lab Technician on consolidated pay of Rs.5000/- per month to 385 Mobile Medical Units.

2) In the Government Order fourth read above orders have been issued permitting the Mission Director, State Health Society to make the enhanced payment to all the contractual post of Laboratory Technicians to be placed under National Rural Health Mission to the 385 Hospital on Wheels from Rs.5000/- to 7000/- per month and to incur the expenditure for National Rural Health Mission fund as approved by the Executive Committee of the State Health Society. In the Government Order second read above orders have been issued among others, the post of Lab Technician Grade III in Urban Primary Health Centers shall be filled up on consolidated pay of Rs.8000/- on contract basis.

3) The Director of Public Health and Preventive Medicine has therefore requested the Government to issue necessary clarification for fixation of uniform contractual pay of Rs. 8000/- for the post of Lab Technician Grade III in 385 "Hospital on wheels" / Mobile Medical Units / Urban Primary Health Centre.

4) The Mission Director, State Health Society in his letter 6<sup>th</sup> read above, has requested the Government to grant permission to pay Rs.8000/- per month to Lab Technician Grade III appointed on contractual basis in Hospitals on Wheels/Mobile Medical Units under National Health Mission as paid for Lab Technician Grade III in the Urban Primary Health Center for uniformity.

5) The Government after careful consideration has decided to accept the proposal of the Mission Director, State Health Society and they accordingly permit the Mission Director, State Health Society to pay uniform contractual pay of Rs.8000/- (Rupees Eight thousand only) per month to all Lab Technicians Grade III appointed on contractual basis in Hospital on Wheels/Mobile Medical Units sanctioned in the Government order first read above under National Health Mission prospectively.
