### ORDER:

The Director of Drugs Control has informed the Government that in order to ensure the availability of essential medical items during the COVID-19 pandemic at reasonable prices to the common man, it is necessary to declare certain items as essential articles under the Tamil Nadu Essential Articles Control and Requisitioning Act, 1949 (Tamil Nadu Act XXIX of 1949) and to fix the maximum retail price for the same.

2. The following notification will be published in the Tamil Nadu Government Gazette, extraordinary, dated 04.06.2021:-

### NOTIFICATION

Under clause (a) of section 2 read with clause (b) of sub-section (2) of section 3 of the Tamil Nadu Essential Articles Control and Requisitioning Act, 1949 (Tamil Nadu Act XXIX of 1949), the Governor of Tamil Nadu hereby declares the following medical items specified in column (2) below, as essential articles to be sold at the maximum retail price specified in column (3) thereof:
