## ORDER:

The Project Director, Tamil Nadu Health Systems Project, has stated that it is proposed to conduct a Project Implementation Completion Review Workshop with the Stakeholders during the World Bank project completion review mission in the month of August 2015. The duration of the workshop may be for two days and the stakeholders to be invited will include Planners, Policy Makers, Health Administrators, Non Governmental Organizations, Representatives of Civil Society, Representatives from organizations partnered with Tamil Nadu Health Systems Project during the course of the project, the Deans of Medical Colleges, Joint Directors and Deputy Directors of Health Services, District Project Management Unit Coordinators etc. He has also stated that the first day of the workshop will be devoted for group discussions and arriving at decisions with a limited number of participants and that the second day of the workshop will be devoted for lectures and presentations. It is also proposed to felicitate the Officers and personalities who had been associated with the project and contributed for the success of the project during the workshop. Accordingly, the Project Director, Tamil Nadu Health Systems Project had placed a proposal before the State Empowered Committee in the meeting held on 13.07.2015 for sanction of Rs.25.00 lakh for conducting the Workshop. The State Empowered Committee had approved the proposal. The Project Director has requested the Government to issue orders in the matter.

- 2. The above activity has been approved by the World Bank and comes under Component III and Sub Component C and the expenditure is eligible for reimbursement from the World Bank.
- 3. The Government grant permission to the Project Director, Tamil Nadu Health Systems Project to conduct State holders workshop for the project completion review workshop.

- 4. The Government, accord sanction for a sum of Rs.25.00 lakh (Rupees Twenty five lakh only) for conducting the above Project Completion Review Workshop.
- 5. The Government permit the Project Director, Tamil Nadu Health Systems Project to reallocate the expenditure within and across the components without exceeding the total cost sanctioned above. He is also permitted to add or reduce the number of participants and number of days the workshop to the conducted based on the need without exceeding the total cost sanctioned.
