In exercise of the powers conferred under rule 48 of the General Rules in Part-II of the Tamil Nadu State and Subordinate Services, contained in Part II of the Tamil Nadu Services Manual, 1987, the Governor of Tamil Nadu hereby relaxes the rule 7(a) of the Special Rules for Tamil Nadu Medical Service in favour Dr. S.Meiyappan and Dr.R.Thenmozhi, so as to enable them to have their temporary service in Tamil Nadu Medical Service regularised”.
