ORDER:

In the reference sixth read above, an amendment to rule 7 of the Adhoc rules governing the post of Assistant Medical Officer (Unani) has been issued with an intention to dereserve the unfilled vacancies under the Communal reservation in the event of no suitable candidate is available in respective Communal Categories so as to fill up the vacancies from any other categories on merit.

2. The Secretary, Tamil Nadu Public Service Commission has stated that as per the General Rules, reservation for Backward Class Muslims (3.5%) and BC other than Muslims (26.5%) are two separate units of operation and they are not complement to each other. If no suitable candidate is available in a particular unit of communal group then it has to be carried forward to the next recruitment. Therefore the Commission viewed on the draft amendment to the said rules that the dereservation be made applicable to all communal categories and was communicated on the said line. However, the orders are issued to the effect that the

unfilled vacancies in all communal categories except for the category of Backward Class are to be dereserved for being filled up from any other categories and the unfilled vacancies in the category of Backward Class are to be carried forward as per the provision of the General Rules.

3. In the reference seventh read above, the Tamil Nadu Public Service Commission has opined that the amendment issued in the Government order sixth read above, is not the intention of the Government to carry forward the unfilled vacancies reserved for BC (OBCM) and to dereserve the vacancies under all other communal categories (including BC Muslim). The Secretary, Tamil Nadu Public Service Commission has requested to delete the expression "other than Backward class" from the amendment issued in the reference sixth read above.

4. The Backward Classes, Most Backward Classes and Minorities Welfare Department has stated that the course of Unani is taught in Urdu language alone. The Muslim candidates alone are studying the medical course in Unani and therefore the post of Assistant Medical Officer (Unani) can be filled up by Muslim candidates. If no Muslim candidates are available, the vacancy reserved for Backward Class (Muslim) may be carried forward to the next year to accommodate to the Muslim candidates in the subsequent year. That Department has suggested that to insert the word "Other than the Backward Class (Muslim)" instead of words mentioned in the said Government order "other than the Backward Class".

5. The following notification will be published in the Tamil Nadu Government Gazette:

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the rules published with the Health and Family Planning Department Notification No.SROB-421/ 76, published at pages 454 to 457 of Part III-Section 1(b) of the Tamil Nadu Government Gazette, dated the 4th August 1976, as subsequently amended.

AMENDMENT

In the said rules, in the proviso to rule 7, for the expression "other than the Backward Class" the expression "other than the Backward Class Muslim" shall be substituted.
