State Health Society – Tamil Nadu – National Health Mission – Construction of new buildings to ten Primary Health Centres at a cost of Rs.540.00 lakh - Final installment – Sanctioned - Orders – Issued.

ORDER:

In the letter third read above, the Mission Director, State Health Society has stated that in Programme Implementation Plan 2015-16, it had been proposed to establish 20 new Primary Health Centres under National Health Mission. The National Programme Coordination Committee (NPCC) of Government of India had approved 10 new Primary Health Centres, with an initial fund allocation of Rs.60.00 lakh being 10% of the total requirement for Civil Works of Rs.600.00 lakh (Rs.60 lakh x 10 Primary Health Centres).

2. In Government order second read above, orders had been issued for establishing 10 new Primary Health Centres on the following places at a total cost of Rs.840.20 lakh:-

An amount of Rs.60.00 lakh was also sanctioned for the construction of new buildings to the above 10 Primary Health Centres being 10% of the overall approval of Rs.600.00 lakh for 10 Primary Health Centres at the rate of Rs.60.00 lakh per Primary Health Centre.

3. The Mission Director, State Health Society has also stated that in Record of Proceedings 2015-16 (APDX), Record of Proceedings 2016-17, Record of Proceedings 2017-18 and Supplementary Record of Proceedings 2017-18, the Government of India has sanctioned Rs.540.00 lakh being 90% of the overall approval of Rs.600.00 lakh to the above 10 new Primary Health Centres.

4. The Mission Director, State Health Society has stated that as per Government order first read above, the above sanctioned amount i.e Rs. 540.00 lakh has been remitted into Government account.

6. The Mission Director, State Health Society has therefore requested Government order in this regard.

7. The Government, after careful examination, accept the proposal of Mission Director, State Health Society and accordingly issue the following orders:-

i) Sanction is accorded for a sum of Rs.5,40,00,000/- (Rupees Five crore forty lakh only) to Mission Director, State Health Society for execution of civil works through Public Works Department in following 10 Primary Health Centres in addition to the fund of Rs.60.00 lakh already sanctioned in Government order 2nd read above:-
