#### ORDER:

In the Government order first read above, orders were issued according sanction for a sum of Rs.4,23,92,445/- towards the procurement of the certain equipments and machinery, stores and equipments and medicine to the Institute of Research and Rehabilatation of Hand and Department of Plastic Surgery, Government Stanley Medical College and Hospital, Chennai, under the following head of account:-

2. In his letter second read above, the Director of Medical Education has stated that from the above sanctioned amount, a sum of Rs.2,08,56,000/- has been

drawn and deposited into the Personal Deposit Account of Tamil Nadu Medical Services Corporation Limited, Chennai towards the purchase of Machinery and Equipments after the funds released by the Government in RE 2018-2019, Whereas a sum of Rs.1,53,81,450/- sanctioned towards Non Recurring expenditure towards the procurement of "Stores and Equipments" has not been claimed and deposited into Tamil Nadu Medical Services Corporation Limited Personal Deposit Account, within the financial year 2018-2019 and therefore the said amount has been surrendered to Government account.

- 3. The Director of Medical Education has also stated that the Dean, Government Stanley Hospital, Chennai has submitted a representation to the Directorate of Medical Education wherein he has stated that certain consumable items and other Store materials which have to be purchased to the Plastic Surgery Department to be active and best for performing the Hand transplant surgery as and when Cadaver received, without any delay. Therefore he has requested this Directorate to make necessary arrangements for the deposit of Rs.1,53,81,450/- into Personal Deposit Account of Tamil Nadu Medical Services Corporation Limited, Chennai which has been sanctioned towards Non Recurring expenditure (for the purchase of "Stores and Equipment") in the said Government order as the said amount has not been deposited into Personal Deposit Account of Tamil Nadu Medical Services Corporation Limited Chennai in the financial year 2018-2019.
- 4. The Director of Medical Education has therefore requested the government to accord financial sanction for a sum of Rs.1,53,81,450 in RE/FMA during 2020-2021, towards procurement of "Stores and Equipment", which has been surrendered into Government account during 2018-19 in the aspect of taking care of the needy poor patients attending in crucial times for performing Hand Transplant surgery at the Institute of Research and Rehabilitation of Hand and Department of Plastic Surgery, Government Stanley Medical College and Hospital, Chennai.
- 5. The Government have carefully examined the proposal of the Director of Medical Education in detail and decided to accept the same. Accordingly, the Government do and hereby accorded financial sanction for a sum of Rs.1,53,81,450/- (Rupees One Crore Fifty three lakh eighty one thousand four hundred and fifty only) towards procurement of "Stores and Equipments", for performing Hand Transplant surgery at the Institute of Research and Rehabilitation of Hand and Department of Plastic Surgery, Government Stanley Medical College and Hospital, Chennai.
- 6. The expenditure sanctioned in para 5 above shall be debited to the following Head of Account:-

7. The Director of Medical Education is directed that the amount sanctioned for stores and equipments shall not be paid in cash but credited to the following Personal Deposit Account of Tamil Nadu Medical Services Corporation Limited:

K Deposit and Advances (b) Deposits not bearing interest – 8443.00 – Civil Deposit – 800 – Other Deposits – CE Deposits of Tamil Nadu Medical Services Corporation Limited (TNMSC) – 801 – Receipts 02 Not Bearing Interest

(Old DPC 8443 00 800 CE 000H) (Receipts) (IFHRMS DPC 8443 00 800 CE 80102)

- 8. Necessary additional funds Rs.1,53,81,450/- will be provided in the FMA 2020-2021. Pending provision of such funds, the Director of Medical Education is authorized to draw and disburse the amount sanctioned in para 5 above. However, this expenditure shall be brought to the notice of the legislature by Specific inclusion in the Supplementary Estimates 2020-2021. The Director of Medical Education is also requested to include this expenditure while sending the budget proposals for FMA 2020-2021 and also send draft explanatory notes for Supplementary Estimates 2020-2021 to Government in Finance (BG-I/Health-II) Department without fail.
- 9. This order issues with the concurrence of the Finance Department vide its U.O.No.22JS(KU) dated.08.02.2021 and ASL No. 1680(one thousand six hundred and eighty).
