ORDER:

In the Government Order first read above, the Government have directed the Medical Services Recruitment Board to recruit 2159 temporary post of Medical Officers [(911 General (MBBS), 1163 Speciality, 85 Assistant Surgeon (Dental) comprising of 54 Assistant Surgeon (Dental-General) and 31 Assistant Surgeon (Dental-Speciality)].

- 2. In the notification 2nd read above, the Medical Services Recruitment Board has notified and conducted examination on 19.5.2013 for the recruitment of Assistant Surgeon (General and Speciality) including Assistant Surgeon–Dental (General and Speciality) as per the directions issued by the Government. The 85 Dental vacancies including 31 vacancies in various Dental specialities were notified for the post of Assistant Surgeon (Dental) (Speciality) and a single common entrance examination was conducted for Assistant Surgeon Dental (General) and for various Assistant Surgeon Dental Specialities. The 31 vacancies were originally arrived at by the Director of Medical Education, based on the number of vacancies that existed at that time and expected consequential vacancies on promotion of eligible candidates from Assistant Professors to Associate Professors, etc.
- 3. In his letter 4th read above, the Chairman, Medical Services Recruitment Board has stated that in the Government Order 3rd read above, among others orders were issued to appoint 19 Assistant Surgeon (Dental) (Speciality) candidates provisionally selected by Medical Services Recruitment Board mentioned in the Annexure II therein.

4. He has also stated that the Government have issued orders promoting certain Assistant Professors (Dental) (Speciality) as Associate Professors in Medical Institutions under the Directorate of Medical Education. Due to the above development, the Director of Medical Education has now furnished a total of 36 vacancies for the post of Assistant Surgeon (Dental) (Speciality) (with MDS qualification) as detailed below:-

- 5. He has sent the revised list of provisionally selected candidates with MDS in various specialities for issuing necessary appointment orders as Assistant Surgeon (Dental) (Speciality) in order to fill up all the 36 vacancies as indicated by the Director of Medical Education in Medical Institutions under the Directorate of Medical Education. He has also stated that the selection of candidates have been done taking into account the marks obtained by the candidates in the competitive examination held on 19.5.2013 and 200 point communal roster etc., for each speciality in MDS. In respect of MDS with any speciality, the selection of candidates was made, after selecting candidates for vacancies in particular specialities, all the remaining candidates were pooled together, taking into account the marks obtained in the examination and duly applying communal roster.
- 6. He has, therefore, requested the Government to issue orders modifying the appointment orders already issued for appointment of Assistant Surgeons (Dental) (Speciality) to fill-up all the 36 vacancy mentioned at para 4 above.

- 7. The Government after careful examination of the proposal of the Chairman, Medical Services Recruitment Board and decided to accept the same. Accordingly, the Government direct that
 - (i) in modification of the orders issued in G.O.(3D) No.44, Health and Family Welfare (B1) Department, dated:13.9.2013 for the temporary appointment of 19 Assistant Surgeon (Dental) (Speciality) as indicated in para 5(ii) and Annexure II of the said Government Order, the 36 candidates as indicated in Annexure to this order are temporarily appointed as Assistant Surgeon (Dental) (Speciality) in the existing vacancies in Tamil Nadu Medical Service.
 - (ii) the Director of Medical and Rural Health Services is directed to conduct a counseling and give posting orders to the selected candidates based on the vacancies furnished by the Director of Medical Education. If there is no vacancy in a particular speciality, to post that selected speciality candidates in vacancies which require MDS with any speciality and subsequently post in their own speciality, as and when vacancies arise.
