### **ORDER:**

In the Government order first read above, the adhoc rules for the post of Electro Cardiogram Operator in the Thoracic Surgery Department and in the Cardiology Department in Government General Hospital, Madras, have been issued. At present, the Electro Cardiogram Operator posts are required in the Thoracic Surgery Department and Cardiology Department of the Government Hospitals. Now 2 posts of Electro Cardiogram Operator have also been created to Government Mohan Kumaramangalam Medical College Hospital, Salem under Prathan Mantri Swasthya Suraksha Yojana Scheme in the Government Order second read above. In order to fill up the posts of Electro Cardiogram Operator in Government Hospitals, the following amendment is issued to the existing adhoc rules for the post of Electro Cardiogram Operator.

2. The following Notification will be published in the Tamil Nadu Government Gazette.

### **NOTIFICATION.**

In exercise of the powers conferred by the Proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Adhoc Rules published with the Health and Family Planning Department Notification No.SRO B-513/74 at pages 538-539 of Part III-Section 1(b) of the Tamil Nadu Government Gazette, dated the 11<sup>th</sup> December 1974.

2. The amendments hereby made shall come into force on the date of publication of this Notification in the Tamil Nadu Government Gazette.

## AMENDMENTS.

In the said Rules,-

(1) in rule 1, for the expression, "Government General Hospital, Madras", the expression "Government Medical Colleges and Hospitals" shall be substituted;

(2) in rule 4, for the expression "Head of the Medical Institution", the expression "Head of the Medical Institutions concerned" shall be substituted;

(3) in rule 7, after the proviso, the following provisos shall be added, namely:-

"Provided further that on and from 1.06.1988, the monthly pay shall be calculated in the scale of pay of Rs.1200-30-1560-40-2040:

Provided also that on and from 1.01.1996, the monthly pay shall be calculated in the scale of pay of Rs.4000-100-6000:

Provided also that on and from 1.01.2006, the monthly pay shall be calculated in the scale of pay of Rs.5200-20200+GP 2400.";

(4) after rule 7, the following rule shall be added, namely:-

**"8. Saving Clause.-** Nothing contained in these amendments shall adversely affect any person holding the post on the date of publication of this notification in the Tamil Nadu Government Gazette."
