ORDER:

In the letter read above, the Mission Director, State Health Society has stated that the Government of India have transferred and credited into State Government Account its share towards Grants – in - Aid for Reproductive Child Health (RCH) Flexible Pool including other Programmes during 2017-18 as detailed below:-

- 2. The corresponding 40% of the State Share against the 60% of the Government of India release of Rs. 2,06,00,000/- (Rupees Two crore and six lakh only) works out Rs.1,37,33,333/- (Rupees One crore thirty seven lakh and thirty three thousand three hundred and thirty three only).
- 3. The Mission Director, National Health Mission has requested the Government to issue orders for the release of a sum of Rs.3,43,33,333/- (Rupees Three crore forty three lakh and thirty three thousand three hundred and thirty

three only) towards the Central centre and State share Grants - in - Aid for Reproductive Child Health Flexible Pool including other Programmes during 2017-18 as mentioned above and to authorize him to draw the above amount by reappropriating necessary additional funds from the General component.

- 4. The Government after careful consideration have decided to accept the above proposal of the Mission Director, State Health Society and accordingly sanction a sum of Rs.3,43,33,333/- (Rupees Three crore forty three lakh and thirty three thousand three hundred and thirty three only), being the Central and State share contribution of Grants-in-aid for Reproductive Child Health Flexible Pool including other Programmes during 2017-18 under Tribal subplan component of National Health Mission to the State Health society.
- 5. The amount sanctioned in para 4 above shall be debited to the following Heads of account:-

- 2211-00 Family Welfare -103-Maternity and Child Health -Schemes share between State and Centre -UA-National Health Mission Scheme -09 Grant in aid -03 Grants for Specific Schemes(DPC-2211-00-103-UA-0932).

Pending provision of such funds by way of reappropriation In Final Modified Appropriation 2017-18, the Project Director, Reproductive and Child Health Project / Mission Director, National Health Mission, Tamil Nadu is authorize to draw the amount sanctioned in para 4 above and credit into State Health Society account. However, this expenditure shall be brought to the notice of the legislature by Specific inclusion in the Supplementary Estimates 2017-18. The Project Director, Reproductive and Child Health Project / Mission Director, National Health Mission,

Tamil Nadu is also requested to include this expenditure while sending the budget proposals for FMA 2017-18 and draft explanatory notes for Supplementary Estimates 2017-18 to Government in Finance (Health –I) Department, He is also directed to surrender the amount equivalent to additional provision from the provision under the Head of Account 2211-00 Family Welfare - 103- Maternity and Child Health – Schemes share between State and Centre – UA - National Health Mission Schemes -09 Grants - in – Aid - 103 Grants for Specific Schemes (DPC-2211-00-103-UA-0932) in Final Modified Appropriation, so as to effect the above said reappropriation.
