ORDER:-

During the Budget Session on 12.08.2014, among others, the Hon'ble Chief Minister of Tamil Nadu has announced under rule 110 that,

“சென்னை அரசு பொது மருத்துவமனைக்கு வரும் நோயாளிகளின் எண்ணிக்கையை கருத்தில் கொண்டு, அவர்களுக்கு கூடுதல் வசதிகள் செய்து தரும் பொருட்டு, புற நோயாளிகள் பிரிவு, முடக்கியல் பிரிவு, சிறுநீரகவியல் அறுவை சிகிச்சை பிரிவு மற்றும் சிறுநீரகவியல் மருத்துவப் பிரிவு ஆகியவற்றிற்கு 50 கோடி ரூபாய் செலவில் அடுக்கு மாடிக் கட்டடம் கட்டப்படும்”.

2. Based on the above announcement, the Director of Medical Education has forwarded the rough cost estimate prepared by Engineer in Chief and Chief Engineer (Buildings), Public Works Department, Chennai Region for construction of building for Out patients & other departments at Rajiv Gandhi Government General Hospital, Chennai for an amount of Rs.58.65 crore in the schedule of rates for the year 2014-2015 and Rs.64.51 crore in the schedule of rates for the year 2015-2016, approved by the Engineer-in-Chief and Chief Engineer (Buildings), Chennai, Chennai region and the Chief Engineer (General), Public Works Department, Chennai, duly countersigned by the Director of Medical Education, Chennai. The floorwise details are as follows:-

3. The Director of Medical Education has therefore, requested the Government to accord administrative and financial sanction for a sum of Rs.58.65 crore for the year 2014-2015 and Rs.64.51 crore for the year 2015-2016 by adding 10% for escalation of costs, for the construction of buildings for Out patients and other departments at Rajiv Gandhi Government General Hospital, Chennai.

4. The Government have examined the proposal of the Director of Medical Education in detail and accord administrative and financial sanction for a sum of Rs.58.65 crore (Rupees Fifty Eight Crore and Sixty Five Lakhs only) for the year 2014-2015 for the construction of buildings for Out patients and other departments at Rajiv Gandhi Government General Hospital, Chennai as detailed in para 2 above.

5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:-

“4210-Capital Outlay on Medical and Public Health – 01- Urban Health Services – 110 – Hospitals and Dispensaries (Including Pharmacy) – Schemes in the Twelfth Five Year Plan- II. State Plan – JA Buildings – 16 Major Works” (D.P. C. 4210-01-110-JA-1602)”.

6. The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and the approval of legislature will be obtained in due course. Pending approval of legislature the expenditure will be initially met by an advance from the Contingency Fund which will be issued by the Finance (BG-I) Department. The Chief Engineer (Buildings) shall apply for sanction of advance from Contingency Fund for the required amount in the prescribed format along with a copy of this order to Finance (BG-I) Department. The Chief Engineer (Buildings) shall also send necessary explanatory notes to include the above expenditure in the Supplementary Estimate for the year 2014-2015 to Finance (Health-II) Department at the appropriate time without fail.

7. This order issues with the concurrence of the Finance Department vide its U.O.No.13521/Health-II/2015,dated:10.03.2015 and ASL No.2756 (Two thousand seven hundred fifty six)
