ORDER:

In the circumstances reported by the Director of Medical Education in the letter third read above, the Government accord sanction for revival of one temporary post of Tutor in Pharmacy attached to Thanjavur Medical College, Thanjavur which was originally created as Assistant in Pharmacy in the Government Order first read above and redesignated as Tutor in Pharmacy in the Government Order second read above from 07.07.2008 i.e., from the date of filling up of the post.

2. Sanction is also accorded for further continuance of above one temporary post of Tutor in Pharmacy attached to Thanjavur Medical College, Thanjavur for the period from 07.07.2008 upto 31.08.2009.

3. The holder of the post is eligible to draw besides pay in the time scale of pay of Rs.9300-34800 with Grade Pay Rs.4700/- Dearness Allowance, House Rent Allowance and other allowances admissible as per the orders and the rules in force and subsequent orders issued from time to time.
