ORDER:

In his letter fifth read above, the Director of Medical Education has stated that one post of Professor to each of the Departments viz, Dermato, Venereo and Leprosy and Psychiatry in the scale of pay of Rs.37400-67000 + GP 8700 was originally created to the following institutions in order to satisfy the Medical Council of India norms as detailed below :-

2. The Director of Medical Education has also stated that as per the amendment notification dated 01.07.2015 of Medical Council of India, New Delhi, the requirement of Head of Department in respect of Department of Dermato, Venereo and Leprosy (Dermatology) and Psychiatry have been reduced as Associate Professor instead of Professor where M.B.B.S students were admitted upto 150 per annum. He has also stated that the post of Professor was proposed before the amendment notification dated 01.07.2015 of Medical Council of India, New Delhi. It was, therefore, proposed as Professor instead of Associate Professor.

3. The Director of Medical Education has justified the conversion of the post of Professor sanctioned to the Department of Dermato, Venereo and Leprosy and Psychiatry in respect of certain Medical Colleges as Associate Professor as per revised norms of Medical Council of India and has therefore requested the Government to convert the post of Professor sanctioned to the Department of Dermato, Venereo and Leprosy and Psychiatry in respect of certain Medical Colleges as Associate Professor except Chengalpattu Medical College, Chengalpattu as Associate Professor as per revised norms of Medical Council of India.

4. The Government have examined the proposal of the Director of Medical Education carefully and decided to convert the post of Professor sanctioned to the Department of Dermato, Venereo and Leprosy and Psychiatry in respect of certain Medical Colleges as Associate Professor as per revised norms of Medical Council of India. Accordingly, the Government do and hereby direct that the post of the Professor sanctioned to the Department of Dermato, Venereo and Leprosy and Psychiatry in respect of the following Government Medical Colleges be converted as

Associate Professor in the scale of pay of Rs.15600-39100+ GP Rs.7600 (Revised level of pay – level 26 Rs.61900-196700) so as to enable the Director of Medical Education to fill up those posts by promotion from the feeder category of Assistant Professor:-
