#### **ORDER: -**

The Commissioner of Indian Medicine and Homoeopathy has stated that Principal, Government Yoga and Naturopathy Medical College, Chennai has stated that the Yoga and Naturopathy is an art and science of healthy living and a drugless system of healing based on well founded philosophy, having great health promotive, disease preventive and curative as well as restorative potential but in need of improvement on Medical Education, Research, Hospital Services, IEC (Information, Education and Communication), ICT, Training and Standardization of Therapies. Yoga and Naturopathy wings were started in twenty Primary Health Centres under the National Rural Health Mission Scheme in the year 2009 and as the public response was very good, 31 Yoga and Naturopathy Maternity Clinics were started in 31 districts in Tamil Nadu. Moreover the Hon'ble Chief Minister has announced the establishment of Yoga and Naturopathy Lifestyle Clinics in all the District Head Quarters Hospitals and Modern Medical College Hospital and Government have also announced the starting of Master of Degree Course in Yoga and Naturopathy at Government Yoga and Naturopathy Medical College, Chennai, Yoga and Naturopathy Lifestyle Clinic has been started at Government Multi Super Specialty Hospital and is offering medical services to the public. Hence there is a need to implement and monitor these schemes all over Tamil Nadu. The Department of AYUSH, Government of India is encouraging these systems and more number of schemes are available to implement in Public Health Care System. Hence, the Principal, Government Yoga and Naturopathy Medical College has observed that a technical person at Directorate level is very much required to assist the Commissioner and co-ordinate between Government of Tamil Nadu, Government of India, Medical University, District Level Officers, and Doctors.

Hence, the Principal, Government Yoga and Naturopathy Medical College has opined that Joint Director (ex-officio) for Yoga and Naturopathy is very much required and the Principal of Government Yoga and Naturopathy Medical College may be posted as Joint Director (Ex-officio) in the Commissionerate of Indian Medicine and Homoeopathy, Chennai in addition to his regular College & Hospital works in the same campus without any extra expenditure to the state funds and that there will be no additional expenditure to the Government.

The Commissioner of Indian Medicine and Homoeopathy has therefore requested that one post of Joint Director (Ex-officio) for Yoga and Naturopathy for the Commissionerate of Indian Medicine and Homoeopathy may be sanctioned and the incumbent Principal, Government Yoga & Naturopathy Medical College, Chennai may hold the post in addition to his routine works so as to assist the Commissioner in technical matters and in implementation of the schemes, without any additional expenditure to Government.

3. After careful examination of this proposal, the Government have decided that the post of Principal, Government Yoga and Naturopathy Medical College, Chennai, sanctioned in the Government Order first read above, be designated as Joint Director (Ex-Officio), Commissioner of Indian Medicine and Homoeopathy Department and this post should not be filled up other than by the Principal, Yoga and Naturopathy Medical College, Chennai and also it should not be included in the panel for the post of Joint Director and order accordingly.
