ORDER:

In the circumstances reported by the Director of Medical Education in his letter second read above in partial modification of the orders issued in the Government Order first read above. Sanction is accorded for enhancement of the Permanent Advance to the Office of the Director of Medical Education from Rs.15,000/- to Rs.25,000/- (Rupees Twenty five thousand only).

2. The expenditure shall be debited to 2210 - Medical and Public Health – 05 – Medical Education, Training and Research 001 – Direction and Administration I – Non - Plan AD – Directorate of Medical Education 05 – Office Expenses – 02 Other Contingencies (DPC 2210 – 05 – 001 AA – 0523).

The Director of Medical Education is directed that when the permanent advance is no longer required or when the amount of permanent advance is reduced, the amount not required should be credited into the Treasury / Reserve Bank in full under the same head of account given in para 2 above. After the amount spent out of it is recouped in the usual way and the fact of refund into the Treasury / Reserve Bank should be reported to the Accountant General, Chennai by Special letter. The provisions of articles 94 to 98 of the Tamil Nadu Financial code Volume I, should be followed.
