Order:

In the Government order second read above, the Government have sanctioned a separate division (unit) for Minimal Invasive Surgery under the General Surgery Department of Rajiv Gandhi Government General Hospital, Chennai headed by an Associate Professor, who has Specialized Qualification in the arena (recognized by a Medical University), with no additional recurring and non-recurring financial burden to the Government.

2. In the Government Order third read above, permission was granted to the Dean, Madras Medical College, Chennai to start 'two year' Post Doctoral Fellowship Programme in Minimal Access Surgery from the year 2014-2015 subject to certain conditions.

3. The Director of Medical Education has proposed in her letter fourth read above, for up-gradation of the unit of Minimal Access Surgery into a department and for creation of new posts of Assistant Professor exclusively to

the Minimal Access Surgery Unit as recommended by the Inspection Commission of Tamilnadu Dr.MGR Medical University while granting provisional affiliation for the Post Doctoral Fellowship Course in Minimal Access Surgery.

4. Post-Doctoral Fellowship course in Minimal Access Surgery was started by the National Board of Examinations in 2005 and by the Tamil Nadu Dr.MGR Medical University in 2010 and existent only in Private Hospitals and that Madras Medical College/ Government General Hospital is the first Government Medical College Hospital in the Country to start the same, and many patients have undergone Minimal Access Surgery and also availed the same through the Chief Minister's Comprehensive Health Insurance Scheme. Therefore upgrading the unit into a department will facilitate sharing of expertise and imparting specialized training and increasing the number of experts in the field. This will benefit the public and also facilitate smooth running of the Fellowship course as envisioned by the Medical Council of India.

5. The Inspection Committee of the Tamil Nadu Dr.MGR Medical University had recommended that Assistant Professor posts may be created to the Minimal Access Surgery Unit for better patient management and to help in the Post-Doctoral Fellowship training while granting provisional affiliation for the Fellowship course. Hence, the Director of Medical Education has requested the Government to redeploy the three posts of Non-Medical Tutor (Scale of pay Rs.15600-39100+ G.P Rs.5400/-) sanctioned to Kanyakumari Medical College Hospital, Kanyakumari to Madras Medical College, Chennai and they may be upgraded as Assistant Professor in the scale of pay of Rs.15600-39100+G.P Rs.5700/- exclusively for the Department of Minimal Access Surgery, Madras Medical College/Government General Hospital, Chennai.

6. The Government have examined the proposal of the Director of Medical Education in detail and accord sanction:-

- a. to upgrade the existing Minimal Access Surgery Unit in Madras Medical College, Chennai as Department of Minimal Access Surgery.
- b. to create three (3) posts of Assistant Professors in the scale of pay of Rs.15600-39100+G.P.5700/- exclusively for the Department of Minimal Access Surgery, in lieu of surrender of three posts of Non-Medical Tutors (Scale of pay Rs.15600-39100+ G.P Rs.5400/-) originally created in the Government Order first read above, for Kanyakumari Medical College, Kanyakumari at an average annual recurring cost of Rs.81,360/-(Rupees Eighty One Thousand Three Hundred and Sixty only).

7. The expenditure sanctioned for the posts created in the para 6 (b) above shall be debited to the following head of account.

“2210- Medical and Public Health -05 Medical Education, Training and Research-105 Allopathy – I-Non Plan – AA-Chennai Medical College 01-Salaries (DPC 2210 – 05 -105 – AA - 0103)”.
