ORDER:-

In his letter size read above, the Director of Medical Education has sent the proposal to re-transfer the District Head Quarters Hospital, Pudukottai which was already transferred to the Director of Medical Education side from the Director of Medical and Rural Health Services side. He has stated that now Government Pudukottai Medical College Hospital, Pudukottai, is functioning in new site with all infrastructure facilities viz. Buildings, Equipment, Medical, Para Medical and Administrative Staff.

- 2. The Director of Medical Education has further stated that the wards and other areas of the erstwhile Government Headquarters Hospital, Pudukottai has been completely vacated and kept idle. Since this premises is very nearer to Bus stand, people find it easy to reach the place and requested to reopen the Hospital in that premises. Further, he has stated that the Hon'ble Health Minister has instructed to take over the above said premises and to run a Government Hospital, in that premises immediately. He has, therefore, requested the Government to issue necessary orders to hand over the entire premises of erstwhile Government District Headquarters Hospital, Pudukottai, from the administrative control of Directorate of Medical Education, to the Directorate of Medical and Rural Health Services, Chennai.
- 3. The Director of Medical and Rural Health Services, in his letter seventh read above, has also stated that the Hon'ble Minister for Health and Family Welfare has convened a meeting, at Government Multi Super Speciality Hospital,

Omandurar, Chennai, towards the utilization of the erstwhile infrastructure of District Headquarters Hospital, Pudukottai for providing Secondary Care Medical facility to the Public. During the meeting, it has been concluded that the aforesaid erstwhile District Headquarters Hospital, Pudukottai may be converted and revived into 100 bedded Government Hospital as in the case of District Headquarters Hospital, Villupuram converted as Taluk Hospital.

- 4. The Government have examined the proposal of the Director of Medical Education and Director of Medical and Rural Health Services in detail. In the Government Order second read above, orders have been issued to transfer the Head Quarters Hospital at Pudukkottai District functioning under the control of Director of Medical and Rural Health Services to the administrative control of Director of Medical Education with infrastructure and staff. After completing the entire work in the new site for the construction of Hospital for the Government Pudukottai Medical College Hospital, Pudukottai, the entire equipment along the manpower of the Government Headquarters Hospital, Pudukottai have been shifted to the new premises of the Medical College Hospital. At present, the premises of the Government Headquarters Hospital, Pudukottai is in idle condition and therefore, it has been decided to retransfer the premises of the Government Headquarters Hospital, Pudukottai from the administrative control of the Director of Medical Education to the administrative control of Director of Medical and Rural Health Services so as to provide secondary care medical facility to the public. Accordingly, the Government do and hereby direct that the entire premises of erstwhile Government District Head Quarters, Pudukottai be transferred from the administrative control of the Director of Medical Education to the administrative control of Director of Medical and Rural Health Services so as to provide secondary care medical facility to the public.
- 5. The Director of Medical Education and Director of Medical and Rural Health Services are directed to take necessary action accordingly.
