ORDER:

In the Government order first read above, orders were issued sanctioning Rs.2,73,000/- (Rupees Two lakh and seventy three thousand only) towards payment of monthly rent at Rs.21,000/- per month to the Office of the Deputy Director of Health Services, Tiruvarur which is functioning in a private building at Door No.3/349A, Vilamal Village, Ezhil Nagar, Tiruvarur for the period from 01.02.2012 to 28.02.2013 (13 months).

- 2. In his letter second read above, the Director of Public Health and Preventive Medicine Department has stated that the Deputy Director of Health Services has submitted proposal for sanction of rent at Rs.21,000/- p.m. towards payment of monthly rent for his office for the period from 01.03.2013 to 30.11.2013. The Director has stated that the rent exceeds his financial limit of Rs.12,500/-. He has, therefore, requested the Government to sanction a sum of Rs.1,89,000/- (Rupees one lakh and eighty nine thousand only) towards payment of monthly rent at Rs.21,000/- per month to the office of the Deputy Director of Health Services, Tiruvarur for the period from 01.03.2013 to 30.11.2013 (9 months).
- 3. The Government, after careful examination, have decided to accept the proposal of the Director of Public Health and Preventive Medicine Department and accordingly they sanction a sum of Rs.1,89,000/- (Rupees One lakh and eighty nine thousand only) towards payment of monthly rent at Rs.21,000/- p.m. to the office of the

Deputy Director of Health Services, Tiruvarur for the period from 01.03.2013 to 30.11.2013 (9 months).

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account

"2211 - 00 - Family Welfare - 001 - Direction and Administration - Schemes in the Twelfth Five Year Plan-III Centrally sponsored - SF - Direction and Administration for CSSM and sub centres - 06 Rent, Rates and Taxes - 01 Rent (DP Code 2211-00-001- SF 0618)"

- 5. Necessary additional funds will be provided in Revised Estimate / Final Modified Appropriation 2015-2016. Pending provision of funds, the Director of Public Health and Preventive Medicine is authorized to draw and disburse the amount sanctioned in para 3 above. The Director of Public Health and Preventive Medicine is requested to include the expenditure while sending the budget proposals for Revised Estimate / Final Modified Appropriation 2015-2016 to Government in Finance (Health-I) Department without fail.
