#### ORDER:

In Government Order first cited orders were issued to establish three De-addiction Centres in the District Headquarters Hospitals at Cuddalore, Kancheepuram and Tiruppur districts.

- 2. The Mission Director, State Health Society in his letter third read has stated that the above proposal was placed in 31<sup>st</sup> Executive Committee meeting and a sum of Rs.150 lakh had been approved for constructing new buildings for accommodating 30 beds, at rate of Rs.50 lakh each, for the establishment of De-addiction Centres in the above said 3 District Hospitals. He has further stated that as per the directions issued in Government Order second read above, the fund of Rs.150 lakh had been remitted into Government of Tamil Nadu account, vide Challan No 375 dated 03.01.2017 of State Bank of India, Treasury Branch, Thousand Light, Chennai.
- 3. The Mission Director, National Health Mission has therefore sent proposal and requested to sanction the amount of Rs.150 lakh for construction of new buildings to the De-addiction Centre at the hospitals Cuddalore, Kancheepuram and Thiruppur.
- 4. The Government examined the proposal of the Mission Director, National Health Mission carefully and issued following orders:
  - An amount of Rs.1,50,00,000(Rupees One crore and fifty lakh only) sanctioned to Mission Director, State Health Society for execution of civil

- works to the 3 De-addiction centres in 3 District Hospitals at Cuddalore, Kancheepuram & Thiruppur at the rate of Rs.50.00 lakh each through Public Works Department.
- ii. The Engineer in Chief and Chief Engineer buildings Public Works Department, Chennai shall be permitted to issue orders to the Executive Engineers of the concerned divisions for the drawal of funds
- 5. The amount sanctioned in para 4(i) above shall be debited into the following head of account:

4211-00-capital outlay on Family Welfare 103- Maternity and Child Health-Central sector schemes SA-National component-Reproductive and Child Health Project -16- Major works. (DPC – 4211-00-103-SA 1608).

- 6. Necessary funds are provided in Revised Estimate 2017-18. The Chief Engineer / Engineer in Chief (Building), Public Works Department is authorized to draw and disburse the amount sanctioned in para 4 (i) above.
- 7. This order issues with the concurrence of Finance Department vide U.O.No11086/Health I /18, dated: 12.03.2018.
