The Hon'ble Minister for Health and Family Welfare has made the following announcementon the floor of the Assembly for the year 2022-2023 (Announcement No.115)

2. The Mission Director, National Health Mission has stated that, Hon'ble Health Minister made an Announcement on 'Clean Hospital Campaign' as a Sustainable Programme in the floor of the assembly. Hence, she has sent the proposal on Clean Hospital Campaign as a Sustainable Programme in 2671 Government Institutions along with necessary guidelines. The activities of the Programme will be based on the following Thematic areas:

i. Hospital Sanitation and Hygiene.

- ii. Waste Management (Bio medical, Solid, Liquid and General Waste)
- iii. Hospital Support Services like Kitchen, Security, Pharmacy Lab etc.

With regard to this, to conduct, monitor and evaluate the Clean Hospital sustainable programme committees are to be formed at the State, District and Facility level. Needs Assessment, routine monitoring on a daily basis & auditing will be the components to implement & review the process which will be taken up for Star Rating and Ranking of the Public health facilities.

- 3. The Mission Director, National Health Mission has therefore requested the Government to issue necessary orders on the decision point approved in 42<sup>nd</sup> Executive Committee meeting to implement 'Clean Hospital Campaign' Sustainability Plan throughout the 2671 selected Healthcare facilities as per the guidelines / implementation framework and to incur the expenditure by utilizing the existing available funds of Rs 32.70 crore that are approved in RoP 2022 - 24 under Quality Assurance Programme."
- 4. The Government have examined the proposal of the Mission Director, National Health Mission in detail and decided to accept the same. Accordingly, the Government permit the Mission Director, National Health Mission to incur the expenditure by utilizing the existing available funds of Rs 32.70 crore approved in RoP 2022 - 24 under Quality Assurance Programme for implementation of 'Clean Hospital Campaign' Sustainability Plan throughout the 2671 selected Healthcare facilities as per the guidelines / implementation framework.
