### ORDER :

Hon'ble Chief Minister among others has announced that financial assistance of Rs.25 lakh will be sanctioned to the family of the 43 doctors who succumbed to Covid-19, while in service.

2. Under PMGKP (Pradhan Mantri Garib Kalyan Package) Insurance Scheme, an amount of Rs.50 lakh is sanctioned to the family / legal heir of the deceased public health provider both Government / Private, who lost their lives on account of Covid-19 related duty as per the criteria prescribed thereon. The nodal officer for Pradhan Mantri Garib Kalyan Package Insurance Scheme is the Project Director, Tamil Nadu Health System Project. Some of the proposals were found ineligible under norms of Pradhan Mantri Garib Kalyan Package Insurance Scheme. The Government have therefore reviewed such cases for grant of exgratia of Rs.25 lakh under Chief Minister Public Relief Fund to the family / legal heir of the frontline workers engaged in Covid related work, contracted Covid and later lost their lives due to Covid, subject to the following conditions:-

- (i) The official must be engaged in frontline Covid-19 related work.
- (ii) They should have contracted Covid-19 while engaged in frontline covid-19 related work and not from other private contacts.

- (iii) Death should have occurred due to Covid-19 or complications related to Covid.

The Director of Medical and Rural Health Services, the Nodal Officer for the same was requested to send proposals of eligible persons which have not been considered under the Pradhan Mantri Garib Kalyan Package Insurance Scheme for sanction under to Chief Minister Public Relief Fund of State Government.

3. The Director of Medical and Rural Health Services has sent necessary proposals to the Government for sanction of financial assistance from Chief Minister Public Relief Fund to the family / legal heirs of 34 such deceased Covid workers who lost their lives in the references 4<sup>th</sup> read above.

4. In the Government Order second read above, the family / legal heirs of 2 deceased doctors were given financial assistance of Rs.25 lakh each vide cheque drawn by the Mission Director, State Health Society.

5. The Government after careful examination of the proposal of the Director of Medical and Rural Health Services accord sanction for a total sum of Rs.8.50 crore from Chief Minister Public Relief Fund @ Rs.25,00,000/- (Rupees Twenty five lakh only), each to the following 34 family/legal heirs of Government Doctors/Private Doctors/ Health Inspector and Private Ward Assistant who were engaged in frontline Covid-19 related work, contracted Covid-19 and lost their lives as detailed below:-

The Joint Secretary to Government and Treasurer (Chief Minister's Public Relief Fund) is authorized to send a cheque for an amount of Rs.8.00 crore (Rupees eight crore only) in favour of the Director Medical and Rural Health Services, Chennai-6 and send the same to him for disbursement to the legal heirs of the 32 deceased front line workers indicated in Annexure to this Government Order and also Rs.50,00,000/- (Rupees Fifty lakh only) in favour of the Mission Director, State Health Society so as to recoup the above said amount already sanctioned to the family / legal heirs of 2 deceased individuals mentioned in Sl.No.33 and 34 in para 5 above.

7. The Director Medical and Rural Health Services, Chennai-6 is directed to settle the sanctioned amount by following due procedures and obtain the stamped receipt in original duly counter signed by the responsible officer not below the rank of Tahsildar or equivalent and send the same to the Joint Secretary to Government and Treasurer, Finance (Chief Minister's Public Relief Fund) Department, Chennai-9 with a copy marked to the Health and Family Welfare Department.
