ORDER:

In the Government Order first read above, sanction was accorded to incur an expenditure of Rs.8.00 lakhs for installation of the new Electronic Telephone Board with 10 junctions and 6 additional new direct line telephones along with intercom facilities in the new office of the Director of Medical Education located in Kilpauk Medical College Hospital Campus, Chennai by following the usual tender procedure. It was also stipulated therein that the expenditure of Rs.8.00 lakhs sanctioned shall be met from the funds of the Medical Education Selection Committee.

- 2. In the Government Order second read above, the Government have ratified the action of the Director of Medical Education in having diverted two lines meant for EPABX as direct lines for officers of the Directorate and also permitted to incur the recurring expenditure for the above two lines from the budget provision of the directorate.
- 3. The Directorate of Medical Education, Chennai has stated that the Government has been requested to permit to incur the Recurring Expenditure from the Budget for 9 (Nine) Lines (i.e.) 6 (EPABX) and 3 (Officers Room) which were installed on November 2007. The Director of Medical Education requested to ratify the action of having diverted two lines to the officers instead of giving to EPABX board. But, in G.O.(D) No.181, Health and Family Welfare Department,

dated 01.03.2010, the Government have permitted to incur the Recurring expenditure from the Budget, only for Two lines instead of Nine lines, and he has therefore requested the Government to permit him to incur the Recurring expenditure of Rs.1,10,000/- (Rupees One Lakh and Ten Thousand only) approximately from the Budget for remaining lines (i.e.) 7 lines.

- 4. The Government after careful examination, have decided to accept the proposal of the Director of Medical Education and accord to permit her to incur the recurring expenditure of Rs.1,10,000/- (Rupees One Lakh and Ten Thousand only) towards the telephone charges of 7 (Seven) Telephone lines in addition to the two lines already sanctioned in the Office of the Director of Medical Education from the State Budget instead of Personal Deposit Account of the Selection Committee Fund.
- 5. The expenditure sanctioned at paragraph 4 above shall be debited to the following head of account:
- 2210 Medical and Public Health 05 Medical Education Training and Research 001 Direction and Administration I Non Plan AA Directorate of Medical Education 05 Office Expenses 01 Telephone charges (DPC No.2210-05-001-AA-0514)
- 6. Necessary additional funds will be provided in RE/FMA 2014-15 to meet the expenditure sanctioned in para 4 above. Pending provision of such funds in RE /FMA 2014-15, the Director of Medical Education is authorized to draw and incur the expenditure and she is requested to include the expenditure sanctioned above while sending the Budget proposal for Revised Estimate/Final Modified Appropriation 2014-15 to Finance (Health.II) Department without fail.
- 7. This order issues with the concurrence of Finance Department vide its U.O. No.45762/H.II/14,dated.1.9.2014 and ASL No.987 (Nine hundred and Eighty Seven)
