ORDER:

The Project Director, Tamil Nadu Health Systems Project has stated that during the internal departmental reviews and during field inspections, it has been noticed that there is considerable misunderstanding about the protocol to be followed regarding Blood transfusion for pregnant women. Also, during the meeting of 20 Tertiary care Comprehensive Emergency Obstetric and New Born Care Services Hospitals OGicians, Paediatricians and Blood Bank Medical Officers conducted at Government Rajaji Medical College Hospital, Madurai on 21.04.2014 it was unanimously concluded that a protocol is to be formulated for Blood Transfusion to the expectant mothers during Obstetric procedures.

- 2. A Committee consisting of the members shown in the Annexure to this orders was constituted by Tamil Nadu Health Systems Project for preparing Guidelines for Blood Transfusion to the Obstetric procedures. The said committee had prepared guidelines for Blood Transfusion and the draft guidelines was sent to an external agency namely Dr,Neelam Marwaha, M.D., F.A.M.S, Professor and Head of the Department, Department of Transfusion Medicine, Postgraduate Institute of Medical Education and Research, Chandigrah for review and suggestions for modification, they have suggested certain modification which have been duly incorporated in the guidelines.
- 3. The Project Director, Tamil Nadu Health Systems Project has requested to approve the draft guidelines for blood transfusion in Obstetric Practice formulated by the said Committee and reviewed by the external agency for blood transfusion in

Comprehensive Emergency Obstetric and New Born Care Services and other Government institutions in the State.

4. The Government after careful consideration, having accepted the request of the Project Director, Tamil Nadu Health Systems Project and accordingly, hereby approve the draft guidelines for Blood Transfusion in Comprehensive Emergency Obstetric and New Born Care Services and other Government institutions to obstetric procedures as annexured to this order.
