**ORDER:-**

The Principal Secretary / Commissioner of Indian Medicine and Homoeopathy has stated that the Principal, Government Unani Medical College, Chennai has requested for total amount of Rs.5,50,000/- (Rupees Five lakh and fifty thousand only) towards Detailed / sub-detailed head 42. Service and Commitment Charges under 2210-05-103-AC as detailed below:-

2. The Principal Secretary / Commissioner of Indian Medicine and Homoeopathy has requested the Government to provide a sum of Rs.4,90,000/- (Rupees Four lakh ninety thousand only) in the Revised Estimate / Final Modified Appropriation 2015-16 towards meeting the above mentioned expenditure as Rs,60,000/- has already been provided in BE 2015-2016.

3. The Government have examined the proposal of the Principal Secretary / Commissioner of Indian Medicine and Homoeopathy and have decided to accept the same and accord sanction additional amount of Rs.4,90,000/- (Rupees Four lakh and ninety thousand only) [(Rs.5,50,000/-) – (Rs.60,000/-) = Rs.4,90,000/-] to the Government Unani Medical College towards visitation fee for Central Council of Indian Medicine and other allied expenditure.

4. The expenditure sanctioned in para 3 above shall be debited to the following Head of Account:-

Pending provision of such funds, the Principal Secretary / Commissioner of Indian Medicine and Homoeopathy is authorized to incur the above expenditure. The Principal Secretary / Commissioner of Indian Medicine and Homoeopathy is requested to include the above expenditure while sending proposal for Revised Estimate / Final Modified Appropriation 2015-16, to Government in Finance (Health-1) Department, without fail.
