ORDER :

In the Government Order read above, orders have been issued to constitute a Review Committee to review and monitor the suspension of Government servants in Disciplinary cases.

vi)	Director of Family Welfare, Chennai – 6
vii)	Commissioner of Indian Medicine and Homeopathy, Chennai – 106
viii)	Commissioner of Food Safety and Drug Administration, Chennai – 6
ix)	Tamil Nadu State Health Transport Department, Chennai – 32
x)	Director of Drug Control, Chennai – 6
xi)	Principal Secretary / Secretary, Personnel and Administrative Reforms (Trg) Department.

3. The above Committee will monitor and review the delay in finalizing the suspension of the Government servant in a disciplinary proceedings which have not been finalized for a long time.

4. The Review Committee constituted shall conduct the Quarterly meeting to review the suspension cases in disciplinary proceedings under their authority once in three months viz.

(i) End of March (31 st of March)	-	1 st Quarter
(ii) End of June (30 th of June)	-	2 nd Quarter
(iii) End of September (30 th September)	-	3 rd Quarter
(iv) End of December (31 st of December)	-	4 th Quarter
